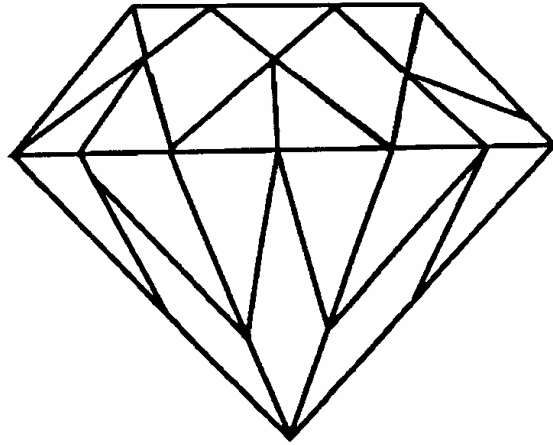

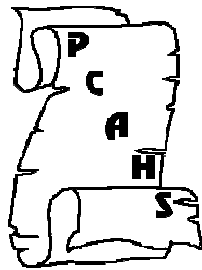

Descendants of Stephen Hipp I

Generation One

1. **Stephen Hipp I**^{1,2,3} was born on June 2, 1683 in Germany; [German Palatinate - In his book *Emigrants From the Palatinate to the American Colonies in the 18th Century*, [1953], Dr. Friedrich Krebs describes the area known as the German Palatinate: "Zweibrucken; on the Schwarzbach, 54 miles southwest of Mannheim. It is known also by the French name, Deux-Ponts. It was for many centuries the capital of the Duchy of Zweibrucken, under the rule of cadet branches of the House of Wittelsbach."]. He married **Ann Walkin** in Newberry District, South Carolina; [It is apparently a German custom for the bride to retain her maiden name and add a suffix of "in" to it indicating she is married. Thus it is possible that the brides names was Ann Walk.]. He died in January, 1782 in Mecklenburg County, North Carolina, at age 98.

The following information relates to the history of the Stephen family in America:

The surname Hipp is often shown as Hipps especially in the Pike County Arkansas family line. The Hipp version will be used herein.

On page 418 of *Pennsylvania German Pioneers* is the following information:

"[List 141 C] At the Court House at Philadelphia, Saturday, the Seventh Day of October, 1749. Present: Thomas Lawrence, Esquire, Mayor. The Foreigners whose Names are underwritten, imported in the Ship Leslie, Captn (sic) J. Ballendine, from Rotterdam, but last from Cowes in England, did this day take the usual Oaths to the Government. By the List 121. 400 Persons from Palatinate, Manheim, Zweybreckt." Among the passengers are Herrs Stephan Hepp; Bernhardt Hepp; Jerg Hepp. There is speculation that these three men were brothers but no proof of that relationship was found.

A Stephen Hipp and Ann Walkin received 150 acres in the province and bounty on January 5, 1761, in South Carolina.

A Stephen Hipp received a land grant in Berkeley District, South Carolina. It was certified by Governor William Simpson on August 3, 1761.

In 1765, Stephen Hyp received a land grant on the east side of the Catawba River on Gar Creek, now in Mecklenburg County, North Carolina.

Stephen's family resided in that part of South Carolina that became the Orangeburg Precinct and in progression, the Old 96 and Camden Districts. The Camden District, South Carolina borders the area of North Carolina that became Mecklenburg County.

Last will and testament of Stephen Hipp

In the name of God, Amen. I Stephen Hipp of the State of No[rth] Carolina & County of Mecklenburg being in good Health & sound mind & memory blessed be God for all his mercies, and calling to mind the mortality of my Body & that it is appointed once for all men to die, Do make this my Last Will & Testament in manner & form following viz. first of all I recommend my body to the Earth from whence it was taken & my soul to God who gave it me nothing doubting but I shall receive the same again at the General Resurrection by the mighty power of my Lord & Saviour Jesus Christ & First I order that all my lawful Debts be paid & fully discharged and I will & bequeath unto my well beloved wife Ann & my well beloved son Andrew one hundred acres of Land whereon I now live together with all my household furniture and at the death of my well beloved wife Ann the said land & furniture shall be the only sole property of my son Andrew Hipp. I will and bequeath

unto my well beloved son Stephen Hipp the sum of five shillings. I will & bequeath unto my well beloved sons John, George, Joseph & Jacob Hipp all the remaining part of my Land to be Equally Divided between them at their discretion, that each of my said sons John, George, Joseph & Jacob (at my death) shall pay or cause to be paid unto my Well beloved son Valentine Hipp the sum of Five pounds each - And for the true Execution of this my Last Will & Testament I nominate & appoint my well beloved Friends & neighbours George Elliot & John Long to be my Executors. In Witness where of I have hereunto set my hand & affixed my seal this 25th day of August & in the year of our Lord 1781.

Last Will & Testament of Stephen Hipp

In the name of God Amen I Stephen Hipp of the County of Mecklenburgh being of sound and perfect mind and memory, blessed be God, do this 25 day of December in the year of our Lord one thousand eight hundred and twenty six make and publish this my last will and testaments in manner following that is to say.

First I allow my body to be decently buried at the descretion of my Executor.

2. I give and bequeath to my well beloved grandson John Johnston all my mechanical Tools of every description. I give and bequeath my bed and furniture to my beloved granddaughter Peggy R. Johnston whatever other property I may be possessed of at my death. I allow to be put to sale immediate after my decease by my Executor to defray my funeral expenses and if any remainder I allow it to be equally divided between my two grandchildren John Johnston and Peggy R. Johnston and I hereby make and ordain

Thomas T. Johnson my executor of this my last will and testament.

In Witness which I the said Stephen Hipp have to this my last will and testament set my hand and seal the day and year above written.

Signed sealed and published and declared by the said Stephen Hipp the Testator as his last will and testament in the presence of us who were present at the time of signing and sealing thereof.

- 4. iii. **John** was born on December 25, 1759. He married **Judah Hicks** in 1783. He died on November 8, 1835 in Buncombe County, North Carolina, at age 75.

John was listed in the 1790, 1800, 1810 and 1820 census of Newberry District, South Carolina.

- 5. iv. **Valentine** was born in May, 1760 in Santee River area, South Carolina. He married **Margaret Allison** in 1785 in Mecklenburg County, North Carolina. He died on November 9, 1838 in Mecklenburg County, North Carolina, at age 78.

Valentine was listed in the 1790, 1810 and 1820 census of Newberry District, South Carolina.

- 6. v. **Andrew** was born circa 1763. He married **Nancy Allison** on October 7, 1817 in Mecklenburg County, North Carolina. He died on March 16, 1831 in Newberry District, South Carolina.

Andrew was listed in the 1790, 1800, 1810 and 1830 census of Newberry District, South Carolina.

The following information is from **the Bible of Samuel L. Hipp**. There is a note in the Bible stating the Bible was purchased in 1862 for one dollar.

The family of Samuel L. Hipp I was featured in the following biographical sketch from Goodspeed's *Biographical and Historical Memoirs of Southern Arkansas* published in 1890 on pages 329 and 330 annotated by David Kelley for clarity and accuracy.

"John T. Hipp was born in Laurens District, S.C., January 17, 1843. His father, Samuel Hipp, and his mother, Meeky East, were both natives of South Carolina. The former died in 1845. He was a mechanic

by trade. The mother with her five little children remained there until 1857, when she moved to Pike County, Ark. remaining in this locality until the [Civil] war. W.A, the oldest then enlisted in the Sixteenth Arkansas Volunteers, under Gen. Price, and was in the battles at Corinth and Port Hudson, where he was captured; he served until the surrender on this side [west] of the Mississippi River. He married a Miss [Mary] Covington in 1867, and died in 1882. James P. married a Miss [Clarinda] Couch in 1861. He enlisted in the Nineteenth Arkansas Volunteers, in January 1862, and was captured at Arkansas Post, January 11, 1863, being carried to Camp Douglas, Ill.; he was exchanged at City Point, Va., and died at Petersburg, in June 1863. Mary E. married Joseph Baird, in 1864. She is still living. John T. enlisted in [the] Nineteenth Arkansas Volunteers, at the age of nineteen, was wounded and captured at Arkansas Post, January 11, 1863, and carried to St. Louis, Missouri. He was exchanged at City Point, Va., in June 1863, and was in the [Confederate] Army of the Tennessee the rest of the war. He took part in the battles of Chickamauga, Missionary Ridge, Resaca, New Hope, Kenesaw Mountain, Atlanta, Jonesboro, Franklin and Nashville, having been in Pat Cleburne's division of Hardee's corps. Returning to Arkansas after the war, Mr. Hipp was married, November 25, 1869, to Miss Lucinda F. Dickson, a daughter of Samuel [correctly, Sion B.] and Elizabeth Dickson. They have four children: The eldest [Mary W] was born September 5, 1870 and died August 13, 1889, James Olin (was born April 20, 1872 and died October 5, 1882), Fannie E. (was born August 25, 1880 and died October 17, 1881), John Noel (was born November 25, 1885). Mrs. Hipp is a member of the Methodist Episcopal Church, South. Mr. Hipp is a farmer, and owns his farm free from all indebtedness. He has never bought a bushel of corn, nor a pound of meat since his marriage, always having sold more [than] less every year. He is a Democrat, and believes in an honest and a free government. His youngest brother, Samuel F., first married Miss Sebell French; she died, and he then married Miss Nancy Davis. They are living in this county. Mr. Hipp's mother died in January, 1873. She was a Christian of the purest type, and belonged to the Methodist Church, South."⁵

Meeky East was born on December 21, 1819.

Meeky East was listed as a head of household on the census of 1860 in Missouri Township, Dwelling 383, Family 383, Pike County, Arkansas,. Meeky was shown as a white female, age 40 and head of household. She was born in South Carolina. One of her children, J.P. was shown living in the household of B.D. Brock, 10 dwellings away. Enumerated with **Meeky East** were **William Albert Hipp**, **Mary Ann Elizabeth Hipp**, **John T. Hipp**, and **Samuel Leonidas Hipp**.

Meeky East was enumerated with **William Albert Hipp** on the census of 1870 in Page 214, Missouri Township, Brocktown Post Office, Dwelling 37, Family 37, Pike County, Arkansas, Micky was shown at age 59 as a white female widow born in South Carolina. She died on February 1, 1874 at age 54.

Known children of **Samuel L. Hipp I** and **Meeky East** were as follows:

James Pickney Hipp was enumerated with **B.D. Brock** on the census of 1860 in Missouri Township, Dwelling 373, Family 373, Pike County, Arkansas, J.P. was shown at age 21 as a single white male born in South Carolina. He was listed as a farmer.

- + 23. iii. **Mary Ann Elizabeth**, born November 3, 1840 in Laurens District, South Carolina; married **Joseph Alvin Baird**.
- + 24. iv. **John T**, born January 11, 1843; married **Lucinda Frances Dickson**; married **Buena V. McKinnon**.
- + 25. v. **Samuel Leonidas**, born April 21, 1845 in Laurens District, South Carolina; married **Cordelia I. Sebel "Delia" French**; married **Nancy Frances Davis**.

Generation Four

21. William Albert Hipp was born on January 23, 1837. He married **Mary A. Covington** in 1867 in Pike County, Arkansas.⁶ He died on July 31, 1882 in Pike County, Arkansas, at age 45; [Civil War Pension Application 9146, abstracted below indicates the death date and cause of death. - Mary L. Hipp, Brocktown, Pike County, Arkansas (widow) of William A. Hipp (May 29, 1909) ... "my husband died ... July 31 of 1882 ... was drowned in Missouri River in Arkansas." A.A. Stell and Eri Webb (May 29, 1909) citizens of Pike County, Arkansas "well acquainted with applicant's husband William A. Hipp and knew him for 3 years ... that he was a Confederate soldier belonging to Kelley's Company, Regiment Hill's, of Arkansas."].

William Albert Hipp was enumerated with **Meeky East** on the census of 1860 in Missouri Township,

Dwelling 383, Family 383, Pike County, Arkansas, W.A. was shown as 13 years old (he was closer to 23 years old), a single white male born in South Carolina. He was listed as a farmer.

William Albert Hipp was listed as a head of household on the census of 1870 in Page 214, Missouri Township, Brocktown Post Office, Dwelling 37, Family 37, Pike County, Arkansas,. William A. was shown at age 33 as a married white male head of household born in South Carolina. He was listed as a farm laborer with real estate valued at \$300. Enumerated with **William Albert Hipp** were **Meeky East**, **Mary A. Covington**, and **Millie D. Hipp**.

William Albert Hipp was listed as a head of household on the census of 1880 in Page 428, Thompson Township, Dwelling 246, Family 246, Pike County, Arkansas,. William A. was shown at age 33 as a married white male head of household born in South Carolina. His mother was born in South Carolina and his father was born in South Carolina. Enumerated with **William Albert Hipp** were **Mary A. Covington**, **Millie D. Hipp**, **Cora A. Hipp**, **Alvin Curtis Hipp**, and **Marvin K. Hipp**.

Mary A. Covington; [Some sources list the name as Mary L.] was born in January, 1844 in Kentucky.

Mary A. Covington was enumerated with **William Albert Hipp** on the census of 1870 in Page 214, Missouri Township, Brocktown Post Office, Dwelling 37, Family 37, Pike County, Arkansas, Mary L. was shown at age 24 as a married white female born in Kentucky.

Mary A. Covington was enumerated with **William Albert Hipp** on the census of 1880 in Page 428, Thompson Township, Dwelling 246, Family 246, Pike County, Arkansas, Mary L. was shown at age 36 as a married white female born in Kentucky, wife of William. Her mother was born in Kentucky and her father was born in Kentucky.

Mary A. Covington was listed as a head of household on the census of 1900 in Page 91B, Thompson Township, Dwelling 32, Family 32, Pike County, Arkansas,. Mary L. was shown at age 36 as a widowed white female head of household born in January 1844 in Kentucky. She was shown as having four children and all four were still living at the time of the census. Her mother was born in Kentucky and her father was born in Kentucky. Enumerated with **Mary A. Covington** were **Alvin Curtis Hipp** and **Marvin K. Hipp**.

Known children of **William Albert Hipp** and **Mary A. Covington** were as follows:

26. i.**Millie D**; [One source has the name as Mattie D.] was born in 1869 in Pike County, Arkansas.

Millie D. Hipp was enumerated with **William Albert Hipp** on the census of 1870 in Page 214, Missouri Township, Brocktown Post Office, Dwelling 37, Family 37, Pike County, Arkansas, Metta D. was shown at age 1 as a single white female born in Arkansas.

Millie D. Hipp was enumerated with **William Albert Hipp** on the census of 1880 in Page 428, Thompson Township, Dwelling 246, Family 246, Pike County, Arkansas, Millie D. was shown at age 11 as a single white female born in Arkansas, daughter of William. her mother was born in Kentucky and her father was born in South Carolina.

27. ii.**Cora A** was born circa 1872 in Pike County, Arkansas.

Cora A. Hipp was enumerated with **William Albert Hipp** on the census of 1880 in Page 428, Thompson Township, Dwelling 246, Family 246, Pike County, Arkansas, Cora A. was shown at age 8 as a single white female born in Arkansas, daughter of William. her mother was born in Kentucky and her father was born in South Carolina.

- + 28. iii.**Alvin Curtis**, born February 11, 1873 in Murfreesboro, Pike County, Arkansas.

29. iv.**Marvin K** was born circa 1876 in Pike County, Arkansas. He married **Elnora French** on March 24, 1904; [He was 26. She was 21. Both people were living in Pike County, Arkansas prior to the wedding].⁷

Marvin K. Hipp was enumerated with **William Albert Hipp** on the census of 1880 in Page 428, Thompson Township, Dwelling 246, Family 246, Pike County, Arkansas, Marvin was shown at age 4 as a single white male born in Arkansas, son of William. his mother was born in Kentucky and his father was born in South Carolina.

Marvin K. Hipp was enumerated with **Mary A. Covington** on the census of 1900 in Page 91B, Thompson Township, Dwelling 32, Family 32, Pike County, Arkansas, Marvin K. was shown at age 23 as a single white male born in April 1877 in Arkansas. His

mother was born in Kentucky and his father was born in South Carolina.

23. Mary Ann Elizabeth Hipp was born on November 3, 1840 in Laurens District, South Carolina. She married **Joseph Alvin Baird** on June 8, 1864 in Pike County, Arkansas; [It is likely that she is his second wife since she was still living with her mother in the 1860 census.].⁶ She died on August 18, 1894 in Prescott, Nevada County, Arkansas, at age 53.

Mary Ann Elizabeth Hipp was enumerated with **Meeky East** on the census of 1860 in Missouri Township, Dwelling 383, Family 383, Pike County, Arkansas, M.A.E. was shown at age 18 as a single white female born in South Carolina.

Mary Ann Elizabeth Hipp was enumerated with **Joseph Alvin Baird** on the census of 1870 in Page 214, Missouri Township, Huddleston Post Office, Dwelling 33, Family 33, Pike County, Arkansas, Mary was shown at age 29 as a married white female born in South Carolina.

Joseph Alvin Baird was born circa 1831 in Tennessee.

Joseph Alvin Baird was listed as a head of household on the census of 1870 in Page 214, Missouri Township, Huddleston Post Office, Dwelling 33, Family 33, Pike County, Arkansas,. He was shown at age 39 as a married white male head of household, born in Tennessee. He was listed as a farmer with real estate valued at \$35. Enumerated with **Joseph Alvin Baird** were **Mary Ann Elizabeth Hipp, Laura J. Baird, Robert A. Baird, Susan Baird, Forest Ellen Baird, and Meeky M. Baird.**

ALFRED RODGERS AND THE CIVIL WAR

My name is Linda Raye Spicer Evers. My father was Charles Edward Spicer, and my mother was Dovie Charlene Young Spicer. Her parents were Zacharia Moses "Zack" Young and Lula Rodgers Young.

Dad was born in Dahlgren, Illinois (Hamilton County) but migrated to Magnolia, Arkansas in 1910 when he was 5 years old. Magnolia, Arkansas is in Columbia County, and there the people were solidly Confederate during the Civil War. In 1910, most of the people living there were "Straight-Ticket Democrats". Dad told us once that early in his years of schooling he made the sad mistake of wearing a Republican button to school during an election. I can only guess what kind of melee occurred that day on

the schoolyard. He told me he never made that mistake again, and he left the rest to my imagination.

Daddy met Mamma at Daisy, Arkansas when he was working with a work program initiated by the government. This program was designed to put young men to work during the depression. The men were building parks and roads through Pike County. Once the government job was over, Daddy continued to drive back to see Mamma until he had "wooded" her enough to convince her to marry him. They married on November 11 of 1934 and went to Columbia County where they could temporarily "sharecrop" on his parents farm.

This "temporary work" lasted 7 years. Dad worked in the public when there was work to be had, but tried to raise cotton as a cash crop. Mother tended to the vegetable garden to provide food for the table. My sister Janis Louise Spicer was born on August 15, 1935, and I was born April 10, 1939. I had a younger brother Ronnie Hugh Spicer who came along later. He was born January 24, 1943.

During the 7 farm years, Dad left us on the farm while he worked short jobs. However, when I was three World War II construction started "big time". Since dad had 6 years of college and was trained for the civil-engineering trade, he worked steadily from then on. It was not long before we were living in El Dorado, Arkansas. He worked on The Lion Oil Chemical Plant construction for awhile, and then he helped construct the new El Dorado Municipal Airport on the Magnolia highway.

When I was 6 years old he went on regular with Lion Oil Company in El Dorado, and worked for them until he retired some 25 years later.

El Dorado was very "Pro-Southern" and so I didn't dwell too much on "the Civil War persuasions" in Dad's background. I was quick to mention that I thought some of my folks on his side of the family were still in England during the Civil War anyway! This news seemed much more popular than my having "Union persuasion background."

I always counted on the fact that Mom was a "True Southerner" and that was at least half of my ancestry, so I left things at that.

My mother's parents died while I was in grade school, and I cannot really remember much that they told me. Although Pike County is not that far from Union County, the roads back then were dirt roads and made traveling back and forth, slow, tedious and awfully dusty. I remember "eating dust" behind another vehicle for miles when I was little on one of our infrequent trips.

I do remember visiting my cousins when my grandparents were sick before they died. After their death making a vacation to Lake Narrows and staying at the Daisy State Park was a yearly occurrence. I met Mom's relatives, but never really knew "who was who" or how all were connected to each other.

Mom died when she was 50; so I was not old enough yet to really "ask all the questions I should have asked while I could." However, Mother and I had an opportunity of being "just the two of us" one summer when I was in my early high school years. It was then that she told me a story I never forgot. My sister had married already. My brother was away on the east coast at a Boy's Scout Jamboree. Dad was away in Missouri for a few weeks. Mamma and I were "holding down the home fort" and were harvesting water melons and were shelling peas to store away for the winter season. We had stopped for a short break and were stretched out on her bed resting. She told me that her ancestor had fought in the Civil War. She added that he had permission to come home, but after coming home he had realized that it was not safe to be there. His farm was being raided by both the North and the South, and if he were found there by one side, he would be considered a "traitor." If the other side found him, he would be considered a "deserter". She said he decided to hide in the hills and remained there for about 6 months.

She continued that meanwhile, his wife was there at the farm with the children. Both the Northern troops and the Southern troops raided them and took whatever they wanted. She specifically mentioned "chickens that the family needed for food" as a favorite item for routine confiscation. Then she told me the most memorable story about a "\$20 goldpiece."

As I remember the story, she only had one \$20 goldpiece to her name and very little else in spendable funds. She somehow knew that there was another imminent raid to suffer through. She also had fear that if they were searched she might well lose her last remnant of spendable security. She hurriedly laid out a plan to save her precious coin. She had one of the daughters open her mouth, and she deposited the goldpiece under the daughter's tongue. She then told the girl to pretend to be a "mute". She emphasized the importance of succeeding with this venture by telling her, "If you say one word while the soldiers are here, I will cut your tongue out when they leave!"

The daughter "played her part" and the money was saved from the soldiers. This story was tucked away in a back corner of my brain, but I never quite forgot it.

Mom died in 1964. Her older brother, Finis Young, was already dead and her younger sister Hortiere Young Berryman lived in Florida. I was living off in Houston, Texas by that time with my husband Jerry and our two daughters. Somehow I never could find time to venture with my visiting much beyond Union County Ark where my Dad and my in-laws all lived. That was always home to me in spite of the fact that I grew up listening to Mother's rendition of Pike County's being "God's Country".

I did not know any names further back than my grandparents on Mother's side. I thought that there was no way to piece anything back together with

Mother's family's having "melted in thin air" as they had.

In 1993, however, my father-in-law died. By then my father had been dead some 15 years and my mother-in-law had been dead for a couple of years. When my father-in-law, Barney Evers, died, it seemed the end of an era. His family all loved him dearly and we all were sad to see him pass. At the same time for the first time in a number of years, I found that I could use my vacation from my job to take a short visit up to Pike County and look around for clues of my "roots."

On that trip I found the funeral home that had handled both of my grandparent's funerals. The funeral home had copies of both their death certificates. Grandma's certificate listed Alfred Rodgers as her father.

I subsequently found a census which gave his approximate date of birth as about 1819 in Tennessee. I realized that Alfred must be the "Ancestor" mother was talking about. Somehow, I had thought it would be further back than Mother's grandfather, but Alfred had 11 children and my grandmother was the youngest of the 11.

Although she had a half-brother old enough to serve and die in the Civil War, she was not born until 1878 long after the war was over.

As time passed, I finally made a trip to the Clayton Genealogy Library in Houston, TX and attempted to look for Alfred Rodgers in an Arkansas Confederate Soldier book, but found nothing. As I was placing the book back on the shelf and thinking that I would never know how Mother's story fit with reality, I spied another book. The name of the book was "Arkansas Damned Yankees" by Desmond Walls Allen. It listed all the Union Soldiers during the Civil War Conflict along with pertinent information regarding their Unit, their rank and company, when and where they enlisted, their age and birthplace. You guessed it! My great-grandfather, the grandfather of my "100% Southern Mother" was a "Damned Yankee."

Another story I remember Mother having told me several times was that the people in Pike County were so mistreated by "carpetbaggers" after the war was over. They "came in and ran the place and became wealthy at the expense of the general population," was the general theme of her rhetoric.

In searching through available information I recall reading that Pike County and the adjoining counties were cut in size and a new county was formed as punishment for Pike County's having participating in the rebellion. I believe what I read indicated that Howard County (the new county formed) was named after a Mr. Howard who came in to run things after the war was over. (I know what I read might have been bias, but it fit with my mother's rhetoric).

I will always wonder. Did Mother know her grandfather served on the Union side? If so did she keep quiet about it because it was so unpopular to live in Arkansas and be on the Union side of things?

Maybe, instead, her mother grew up feeling this unpopularity and told the war story in "general terms". Alfred died January 13, 1898 and Mary was gone after September 5, 1906. Mother was not born until September 9, 1913. Perhaps Grandma never got around to telling her kids what side her father fought on. All I know for sure is that Mother never told me her grandfather was a Union Soldier.

It must have been awful to be in an area so divided between Confederate and Union persuasions. I shudder to think of what would have become of Alfred and his family if the South had won the war. Dad had told us how quickly he learned not to "give away the political sentiments of his family", and now I had learned that Mother's people had felt an even deeper need to keep quiet and allow the "old wounds brought on by the National Conflict to heal."

After finding that he had indeed served as a Union soldier, I was driven to find out (and yet dreaded to know) whether my great-grandfather really had permission to go home or if he was a "deserter." I ordered his war records and eventually pages and pages of information came in the mail.

I am typing a few of the records below to show you that although Mother's story was incomplete, it was basically rather accurate:

DOCUMENT 1

VOLUNTEER ENLISTMENT-STATE OF ARKANSAS, TOWN OF LITTLE ROCK

I Alford Rodgers born in Bedford Co. in the State of Tennessee aged 42 years, and by occupation a Farmer Do HEREBY ACKNOWLEDGE to have volunteered this 20th day of January, 1864, to serve as a Soldier in the ARMY OF THE UNITED STATES OF AMERICA, for the period of THREE YEARS, unless sooner discharged by proper authority; Do also agree to accept such bounty, pay, rations and clothing, as are, or may be established by law for volunteers. And I, Alford Rodgers, do solemnly swear, that I will bear true faith and allegiance to the UNITED STATES OF AMERICA, and that I will serve them honestly and faithfully against all their enemies or opposers whomsoever, and that I will observe and obey the orders of the President of the United States and the orders of the officers appointed over me, according to the Rules and Articles of War. Sworn and subscribed to at Little Rock Ark. the 5th day of July, 1864 Alford (his mark) Rodgers

I certify on honor, that I have carefully examined the above-named Volunteer, agreeably to the General Regulations of the Army, and that in my opinion, he is

free from all bodily defects and mental infirmity, which could in any way disqualify him from performing the duties of a soldier. W. B. Bowers

I Certify On Honor, That I have minutely inspected the Volunteer Alfred Rodgers previously to his enlistment, and that he was entirely sober when enlisted; that to the best of my judgment and belief, he is of lawful age; and that, in accepting him as duly qualified to perform the duties of an able-bodied soldier, I have strictly observed the Regulations which govern the recruiting service. This soldier has light eyes, dark hair, light complexion, is 5' 10" high. William Hollenbeck

He desires to take them north and they are recommended to the kindness of those who sympathize with the sufferings of the Union people of the South.

Clark's Company of the fourth Regiment of Arkansas Cavalry Volunteers, aged 43 years, 5' 10 in. high fair complexion, blue eyes, dark hair and by profession a farmer, born in Bedford County, State of Tennessee and enlisted at Little Rock, Ark, in the State of Arkansas on the 20th day of January, eighteen hundred and sixty-four, to serve for the period of three years is hereby permitted to go to The State of Illinois to take families there, he having received a Furlough from the 24th day of August to the 24th day of September, 1864 at which period he will rejoin his Company or Regiment at Camp Fishback near Little Rock or wherever it then may be OR BE CONSIDERED A DESERTER.

SUBSISTENCE has been furnished to said A. Rodgers to the 20th day of August, 1864 and pay to the 30th day of June 1864 both inclusive.

GIVEN under my hand at Camp Fishback, this 24th day of August, 1864.

Transportation furnished from Duvalls Bluff, Ark. to Memphis Tenn at cost of \$2.80 August 20, 1864 by C. H. Gaubach, Capt.

Notations attached by Quartermaster's offices re 370 miles Memphis, Tenn to De Valls Bluff \$2.80 and Cairo, Ill to Memphis, Tenn.(amt. not legible).

No one in the family seems to know if his wife and children ever left Pike Co, AR. I don't think they did. I think when he got home he realized that it was not safe for any of them to travel and that he would just have to hide in the hills until it was safe to go back to his division What we do know is that he was back with his Regiment by November 20, 1864 (4 months from the time he left). In the files is the following letter:

he returned to the Regiment as soon as he was able to do so. He has always been a good Soldier and has recovered his health Sufficiently to enable him to perform the duties of a Soldier. He returned to the Regiment about the 20th of November last, had been dropped from the Rolls as a deserter. I have the honor to reunite.(last word not clear)

DECLARATION FOR WIDOW'S PENSION AND CLAIMED UNDER ACT OF JUNE 27TH 1890 STATE OF ARKANSAS) COUNTY OF PIKE)

On this 11 day of March A.D. one thousand eight hundred and ninety-eight, personally appeared before me Sidney D. Sutton a Notary Public within and for the County and State aforesaid, Mary E. Rodgers, aged 60 years, a resident of the Town of Star of the West, County of Pike, State of Arkansas, who being duly sworn according to law, declares that she is the Widow of Alfred Rodgers, who enlisted under the name of Alfred Rodgers at Little Rock, Arkansas on the 20 day of January, 1664, as a private in L 4 Regiment Arkansas Cavalry Volunteers; and served at least ninety days in the late war of the rebellion and was honorably discharged at Little Rock Arkansas, on the 30 day of June, 1865 and died at Pike County, Arkansas on the 13 day of January, 1898.

That her said husband Alfred Rodgers, as above stated, was at date of his death a pensioner of the United States, under Certificate Number 541. 683 at Twelve Dollars per month dated 13 day of December 1892.

That she was first married at Pike County, Arkansas on or about the 20 day of December, 1856, By Parson Samuel Kelley, to Alfred Barnes under her maiden name of Mary E. Holcomb and that her said first

husband Alfred Barnes died at Pike County Arkansas on or about the 27 day of February, 1859.

That her soldier husband, Alfred Rodgers as above-named, was first married at Walker County, Alabama on or about the 10 day of October, 1847, by unknown, to Miss Amanda McLain who died at Pike County, Arkansas, on or about the 1 day of April, 1859.

That she, claimant herein, was married under her name of Mrs. Mary E. Barnes as the surviving widow of the said Alfred Barnes, deceased, as above-stated, at Pike County Arkansas, on or about the 27 day of October, 1859, by Parson Wesley Greene, to her soldier husband Alfred Rodgers, as above stated, who died on the 13 day of January 1898, at Pike County, Arkansas.

That no legal barrier was ever known to exist to either one of the above marriages

That neither she nor her soldier husband, Alfred Rodgers ever contract any other marriage than herein set forth, and that she has not remarried since the death of her soldier husband Alfred Rodgers and that she has no children under sixteen years of age.

That she is without other means of support than her daily labor; and is dependent upon those not legally bound to contribute to her support and maintenance, and that at the present time she is an inmate of the home of her son L. S. Rodgers near Star of the West, Pike County, Arkansas and that she is dependent on him for her support and maintenance and that she has no income from any source whatever.

That she makes this declaration for the purpose of being placed on the pension-roll of the United States under the provisions of the Act of June 27, 1890. And for the allowance of arrears of pension due to her late husband Alfred Rodgers as above-stated at date of his death.

She hereby waives Power of Attorney and submits this her claim for adjudication and settlement direct with the Honorable Commissioner of Pensions, Bureau of Pensions, Washington, D. C.

I have been acquainted with him all the time from 1858 to his death. I was acquainted with his former wife (Amanda) Some time in the Spring of the year of 1859 she the said (Amanda) Rodgers died. I lived about 2 miles from the said Alfred Rodgers and his wife (Amanda) at the time. I visited them during her illness and was there present when she died. I do not remember the month or day of the month. I know it was in the spring of the year. This was in Pike Co., Ark the said Alfred Rodgers and Mary E. Barnes were married at Pike County Ark sometime in the fall of the year of 1859. I was not at the marriage but I seen them the next day after they were married. I lived about 1 ½ miles from the said Mary E. Barnes at the time of said marriage. That they lived together as husband and wife from the time they were married to his death. I now that Alfred Rodgers former wife (Amanda) died before he was married to the widow Mary E. Barnes the applicant.

That I have no interest, either direct or indirect, in the prosecution of this claim.

Bear in mind that sometime around 1864 Alfred's son Edward was born into the family and John Alfred (Alfred's oldest son) died on August 13, 1864. What a trying time that must have been for him, for his wife and family!

Although Mother said "he hid about 6 months in the hills", he was really gone only 4 months. He did have permission to go, and he did eventually come back. The excessive lapse of time technically branded him as a "deserter" until he got back. Then he was cleared and reinstated in good standing. Boy, I am so glad the government had kept all these records in such good repair!

I also got his pension records which included affidavits needed for his widow (my great-grandmother) to receive a pension after his death. Members of the family had been trying for years to trace her ancestry back through the "Barnes family", but the various affidavits explained that Alfred Rodgers was married on or about October 10 of 1847 to a Miss Amanda McLain who died on or about the first day of April of 1859. These affidavits also explain that Mary, my great grandmother was married in 1856 to Alfred Barnes and that her maiden name was Mary E. Holcomb. Alfred Barnes died on or about February 27 of 1859, and on or about October 27, 1859 Mary and Alfred Rodgers married each other and lived together until his death.

This was a wonderful gift to clear up her name and the circumstances of their former spouses' deaths.

Also one of the pension papers dealt with a disability Alfred had after the war and his old war record indicated that during the months after he returned from the 4-month absence he would be on active duty for a couple of weeks and then off for a couple due to illness, then on and off again. This indicates to me that perhaps he really was sick while hiding in the hills.

Fran Hawkins asked me to tell the war story and how knowing it opened up this wealth of information about our family. I am sure Fran will tell you that her people came out of the union of Alfred Rodgers and Amanda McClain, and as I have mentioned earlier my people came out of the union of Alfred Rodgers with Mary E. Holcombe. We have tried to share the information we find with each other, and I trust she will tell you about all the offspring and sundry other things she has in her storehouse of information.

I look forward to reading her article.

She died 22 Feb 1941. The following letter was written by Sarah Jane Kelley Lamb to Dow Murray Woodward, aunt of Beverly Murray Moerbe, and is dated March 24, 1937. He found three places to the left of the Hollands. One is most probably a known infant baby of Tom and Ethel Wright Holland.

One of the others could easily Henrietta B.W. Holland's grave. G.W. is known to be buried elsewhere. Christi has shared her research with us. To my delight her family filled-in many pages of our Stewart-Cooley-Kennedy, et.al. lines. Leon, Charles and I went to the Holland family plot located on private property. We made pictures and pulled away some debris. William Holland has a 'bought' stone. There is another unreadable metal marker at his side who I feel certain is Seleta, his wife. There were two other big rocks. According to C.K. and his "wand" a grave is indicated. This property is posted. Seleta had a patent listed in the Arkansas Land Patents book which fits the same description as the area of the Holland plot. William and Seleta also fit the Pike County US Census. C. Watkins also wants to find the unmarked grave of William Hunt in the Mt. Tabor Cemetery.

As you speed with the aid of modern inventions across the plains of eastern Arkansas, you are reminded that you are trespassing on the domain of an ancient civilization where the ghosts of vanished races haunt our times.

Centuries ago those war-like tribes floated down the great river in their pirogues, dispossessing other races to be in turn dispossessed by men with pale faces armed with magic like the gods. What has become of the once powerful Arkansas mighty hunters and warriors, whose name was to be perpetuated on the state's shield?

Gone! Vanished like the mist that scurries over the sea before the rising wind.

Remnants of the Osages and the Quapaws, offshoots from this tribe, still exist, but of those warriors in eastern Arkansas of fine physique and dauntless courage, who forced the marauding Chickasaws to keep their distance, none now remain.

Down the river they came from the land of the Illinois far back along the obscure trails of time. They were hospitable and friendly to the early explorers, and these adventuring Frenchmen repaid their kindness by balling up their name. Marquette referred to them as A-kan-sea; La Salle got it as Ar'-kan-sa, and DeTonti as Ar-kan-ces. Give LaSalle a headmark!

And then, after the poor Indians were gone, leaving no reminders of their stay, but pottery and the name, the whites carried on a newspaper controversy about the pronunciation, which finally was settled by the written statues. Even that has not put a crimp in Yankee usage, and if you go far enough North you will hear the well known "Arkanzas."

It may have been the white man's controversy over the spelling and the pronunciation of the name which caused the Indians to roll up in their blankets and pass away. In the act of Congress

of 1819 creating the territory, the name was spelled "saw" nine times and "sas" once. "Saw" was a 9 to 1 shot.

This division reached the United States Senate, where Senator Sevier was known as the "senator from Arkansaw" and Senator Ashley as the "senator from Arkansas." Finally the state legislature in 1881 put a stop to this foolishness by a resolution which sets forth the proper pronunciation.

Ethnologists agree that the final "s" in Arkansas never should have gotten into print, because the French, who really derived the word from the best they could make of the guttural Indian tongue, did not use the consonant. And it does not mean "smoke water" or "bow" as some profess to believe, but something else known to the Indians which is not any of our business.

When DeSoto led his Chamber of Commerce good will tour into Arkansas he found the Arkansas Indians living in mud-walled villages fortified with high circular towers. They worshiped a Great Spirit known to them as Coyocophil, and also the sun and the moon. Before going to war they painted their bodies black and fasted. after which they painted red, girded up their G-strings and whetted their tomahawks. Time to move on then, Buddy!

Maj. Lewismore Vaugine, who lived in Arkansas 150 years ago, is quoted on a good after dinner story about the Arkansas. He said that in a battle with the Chickasaws, the Arkansas chief learned the enemy was short of powder. He called a truce, commanded his braves to march by squads and dump their powder on a blanket on the ground. Then the Arkansasyer gave the Chick Chief half this powder and the battle was resumed.
