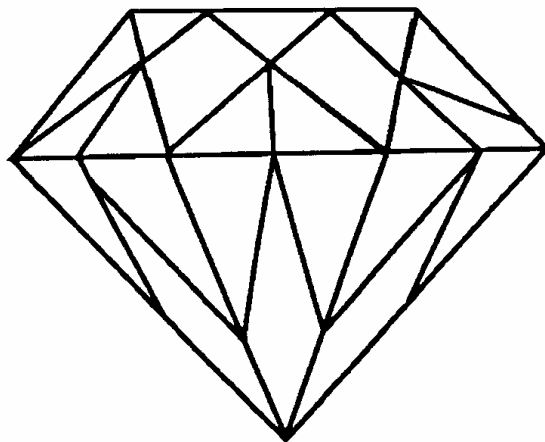

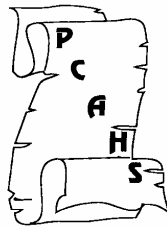

DESCENDANTS OF NANCY ELEANOR PRICE

GENERATION ONE

NANCY ELEANOR-3 PRICE (PETER OLIVER-2, PRICE-1) was born February 22, 1849 in Farmerville, Union Parish, Louisiana, and died July 24, 1908 in Murfreesboro, Pike County, Arkansas. She married (1) ENOCH J. PIERCE, January 7, 1864, in Louisiana, son of LUCKY PIERCE and SARAH BEAIRD. He was born January 11, 1842 in Bibb County, Alabama or possibly Georgia, and died February 20, 1875 in Hope, Hempstead County, Arkansas. She married (2) SAMUEL J. PURTELL, May 30, 1883, in Columbia County, Arkansas, son of THOMAS PURTELL and MARY DEFOOR. He was born September 13, 1847 in Camden, Ouachita County, Arkansas, and died March 18, 1935 in Murfreesboro, Pike County, Arkansas.

Notes for NANCY ELEANOR PRICE: The adoption papers of one of her children say her name was Nancy Ellen. Also the deposition she gave, when her husband Enoch J. Pierce was shot say, Nancy Ellen.

Notes for ENOCH J. PIERCE: ARKANSAS GAZETTE, February 28, 1875, page 4, column 3: "A few days since, a man named E.J. Pierce and a colored man named Brooker Foster became involved in a quarrel, but were separated by friends. The former resided near Hope and the latter just below the village. On the following night, Foster called at Pierce's residence, called the gentleman out, shot and killed him. Foster was arrested, and while attempting to escape, was shot and killed." ARKANSAS GAZETTE, March 2, 1875, page 4, column 2: "The negro who was reported killed at Hope while attempting to escape, seems to have escaped sure enough. He took leg bail while a posse was in search of a coroner." ARKANSAS GAZETTE, July 11, 1875, page 4, column 2: "The Washington Telegraph says Booker Foster is to be hung for murder, in that county on the 15th day of this month for the murder of Mr. Enoch J. Pierce. The case went to the Supreme Court, but the decision there was against Foster." Enoch was in the Confederate Army. He served as a Private in the 17th Louisiana Infantry Regiment, Company C. He enlisted May 16, 1862, Monroe, Louisiana. Roll November and December, 1862, Present. Transferred from 31st to 17th Louisiana, November 18, 1862, order of General Smith. Roll January and February, 1863, Present. Federal Rolls of Prisoners of War, captured and paroled at Vicksburg, Mississippi, July 4, 1863.

Notes for SAMUEL J. PURTELL: Samuel's parents were both born in Alabama according to the 1900 census of Pike County, Arkansas. The census says that they were married 18 years.

Children of NANCY PRICE and ENOCH PIERCE:

NANCY ELEANOR (ELLA)-4 PIERCE, born December 14, 1864, Union Parish, Louisiana; died July 14, 1949, Delight, Pike County, Arkansas.

SARAH JANE ANNETTE (NETTIE) PIERCE, born June 12, 1867, Union Parish, Louisiana; died March 8, 1951, McKinneyville, Freestone County, Texas.

ZELPHA ELIZABETH PIERCE, born February 19, 1869, Union Parish, Louisiana; died May 9, 1919, Belton, Hempstead County, Arkansas.

MARTHA (MATTIE) PIERCE, born February 3, 1871, Union Parish, Louisiana. Notes for MARTHA (MATTIE) PIERCE: I believe she died before 1900. The 1900 census of Pike County, Arkansas. Census says that Nancy Price Pierce Purtell had 7 children and 5 were (then) alive. The 2 that died would be Martha and Roza Ann.

SUSAN CHARITY PIERCE, born September 16, 1872, Farmerville, Union Parish, Louisiana; died June 1959, Chehalis, Lewis County, Washington.

ROZA ANN PERMELIA PIERCE, born February 6, 1875, Hempstead County, Arkansas; possibly died at birth, February 6, 1875, Hempstead County, Arkansas. Notes for ROZA ANN PERMELIA PIERCE: Pete O. Purtell told my Aunt Julia that he thought she died at birth, however there was a baby sitting in her Mother's lap when her father was shot and killed. Her sister Susan Charity was then two years 5 months old.

Child of NANCY PRICE and SAMUEL PURTELL:

PETER OLIVER-4 PURTELL, born September 15, 1883, Farmerville, Union Parish, Louisiana; died May 23, 1969, Dallas, Dallas County, Texas.

GENERATION TWO

NANCY ELENOR (ELLA)-4 PIERCE (NANCY ELEANOR-3 PRICE, PETER OLIVER-2, PRICE-1) was born December 14, 1864 in Union Parish, Louisiana, and died July 14, 1949 in Delight, Pike County, Arkansas. She married HENSON ESTES PHILLIPS, January 18, 1882, in Hempstead County, Arkansas. He was born 1851 in Alabama, and died September 18, 1900 in De Roan Township, Hempstead County, Arkansas.

Notes for NANCY ELENOR (ELLA) PIERCE: Ella's father died when she was still very young. Her mother could not support the children, so she placed them in foster homes. Ella lived with an attorney and his family in Hope. A letter written by Nancy to her sister Susan Charity:

Guernsey, Arkansas
October 6, 1900

Dear Sister,

While you were writing your letter, the Death Angel showed up at my door on Tuesday the 18th of September. He claimed my dear husband. He died of Swamp fever. He was only sick 4 days. He was never able to talk but he knew us all to the last. Drs. Satefus, Sarver and Glispe did all they could but all in vain. My little baby boy was just one month and two days old when he died. I have 9 children to care for. I tell you my hands and heart are full.

We have a good enough harvest gathered, nearly 3 bales of cotton and have about 8 more to gather. The children gathered corn this week. Will make about 200 bushels ... Our first cotton is a good price but I owe a big debt. Am afraid I won't have much left when I pay up. My 2 youngest children are boys. I named the little one for his papa. I had his picture enlarged. Got it the 1st of August. Am glad I did. I wouldn't take anything for it. I am so glad he lived to see it.

Exa says tell Aunt Susie she has to plow. She has no papa to plow for her. You were sadly mistaken when you think Brad sat in the house. He worked hard all the time and studied at night and more when everybody else were resting but poor boy his hopes are blighted for awhile at best. He was never very stout and can't stand farm work and we were trying to give him a chance but if I live he shall yet have ... (missing portion) ... get out of heart but stay with mama a few years and keep up with his studies and he might yet have his hopes realized. I know he is the best boy in the world. But for him I think I would give up. I am helping him all I can.

I have been picking cotton ever since Mr. Phillips died. I have a nurse bottle for the little

baby while I am in the fields ... (missing portion) ... We live in front of S.B. Jones where we lived when Little Roy died. Have been here 6 years. Will stay here next year. Everybody have been so kind to us.

Notes for HENSON ESTES PHILLIPS: The 1900 Hempstead County, Arkansas census shows Henson's father born in Georgia and his mother born in North Carolina.

Marriage Notes for NANCY PIERCE and HENSON PHILLIPS: Estes and Ella were married January 18, 1882, in Hempstead County. She was 18; he was 31. They were married by G.D. Vance, JP. They had a farm four miles west of Hope. All of their children were born while they were living there. Estes died while his children were still very young, so Ella's husband, just like her father, died young leaving a mother with a large family of small children. Ella's mother had remarried and was living in the Saline Creek Community in Pike County, between Delight and Murfreesboro and Ella moved there with her children. She never remarried. Later she homesteaded a place off Strawberry Road near Delight. She was living alone at her home near her daughter Exa in Delight when she died July 14, 1949, at the age of 74. She is buried at Saline Creek Cemetery. Estes is buried in Symona Cemetery near Hope. They had ten children.

Children of NANCY PIERCE and HENSON PHILLIPS:

HENRY BRADFORD (BRAD)-5 PHILLIPS, born July 1882, near Hope, Hempstead County, Arkansas; died Denver, Denver County, Colorado; m. ELLA ----- ; died Denver, Denver County, Colorado. Notes for HENRY BRADFORD (BRAD) PHILLIPS: H.B. married Ella and they were living in Moore, Oklahoma in 1971 when his sister Exa died. Shortly afterward they moved to Denver where their youngest son lived. They both died there in the early 1970's.

HAWTENSE PHILLIPS, born May 1886; married RUBEN HARRIS; born near Hope, Hempstead County, Arkansas. Notes for HAWTENSE PHILLIPS: Hawtense died after 1949. She married Ruben Harris and they lived at Arkadelphia. They had two children.

EXA PHILLIPS, born August 7, 1887, near Hope, Hempstead County, Arkansas; died May 10, 1971, Hope, Hempstead County, Arkansas; married SAMUEL CHASE KELLEY, January 24, 1904, Pike County, Arkansas; born January 18, 1878, Delight, Pike County, Arkansas; died January 24, 1962, Ouachita Hospital, Hot Springs, Garland County, Arkansas. Notes for EXA PHILLIPS: Exa's father passed away the 18th of September, 1900, and Exa had to do the plowing of the fields at the age of 13.

ROY PHILLIPS, born about 1889; died between 1894-1900.

WILL CARLTON (CORY) PHILLIPS, born May 1, 1889, near Hope, Hempstead County, Arkansas; died June 14, 1944, Alexandria, Rapides Parish, Louisiana. Notes for WILL CARLTON (CORY) PHILLIPS: Will is buried adjacent to his mother's grave in Saline Cemetery with the inscription: Ark. PVT CL 312 Mil Police 878 Div.

WENDLE H. PHILLIPS, born July 1891, near Hope, Hempstead County, Arkansas; died before 1910. Notes for WENDLE H. PHILLIPS: Wendle died in his youth.

KATHERINE JOSEPHINE PHILLIPS, born January 1894.

WILLIE ROSE PHILLIPS, born February 11, 1896, near Hope, Hempstead County, Arkansas; died November 10, 1993, Delight, Pike County, Arkansas; married JAMES THOMAS PARSONS, December 22, 1912, Pike County, Arkansas; born November 21,

1888; died February 12, 1971, Delight, Pike County, Arkansas.

CHESTER LEE PHILLIPS, SR., born February 14, 1898; died November 2, 1975, Tyler, Smith County, Texas.

HENSON PHILLIPS, born August 16, 1900, Gurnsey or Hope, Arkansas; died before 1910. Notes for HENSON PHILLIPS: His father died when he was 1 month and 2 days old. Henson died as an infant.

SARAH JANE ANTINETTE (NETTIE)-4 PIERCE (NANCY ELEANOR-3 PRICE, PETER OLIVER-2, PRICE-1) was born June 12, 1867 in Union Parish, Louisiana, and died March 8, 1951 in Mc-Kinneyville, Freestone County, Texas. She married MILAS RICHMOND KELLEY, 1890, in Pike County, Arkansas, son of WESLEY KELLEY and JANE D. (WESSON) PATTERSON. He was born January 6, 1862 in Pike County, Arkansas, and died April 28, 1917 in Freestone County, Texas.

Notes for SARAH JANE ANTINETTE (NETTIE) PIERCE: Buried in the New Hope Cemetery, off HWY 84 between Teague and Mexia, Texas which is west of Hwy. 45 about half way between Dallas and Houston. "Nettie Anna" Sarah Jane Pierce married Milas Richmond Kelley in 1890. They moved to Texarkana, Arkansas and to Buchannen, Texas then Madisonville, Texas about 1894. About 1902 they moved to Bryan, Texas.

MARTHA REBECCA KELLEY, born August 6, 1896, Texas; died December 21, 1982, Teague, Freestone county, Texas [06]; married (1) ALLEN SMITH, Freestone County, Texas; married (2) JAMES MONROE LUVVORN; married (3) IRVIN HEMPHILL BALDREE; born March 27, 1887; died October 12, 1968, Teague, Freestone County, Texas.

J. ALLAN KELLEY, born September 15, 1901.

MARY JANE KELLEY, born March 8, 1904, Texas; died March 5, 1991, Humble, Harris County, Texas; married WILLIAM MARVIN BUTCHER.

EMORY FRANKLIN (FRANK) KELLEY, born April 6, 1907.

ZELPHA ELIZABETH-4 PIERCE (NANCY ELEANOR-3 PRICE, PETER OLIVER-2, PRICE-1) was born February 19, 1869 in Union Parish, Louisiana, and died May 9, 1919 in Belton, Hempstead County, Arkansas. She married ISAAC NEWTON MOORE, August 14, 1884, in Pike County, Arkansas, son of ALEX MOORE and ANN JONES. He was born October 31, 1857 in Arkansas, and died November 18, 1936 in Warm Springs, Randolph County, Arkansas.

Children of ZELPHA PIERCE and ISAAC MOORE:

ROBERT DANIEL-5 MOORE, born March 5, 1887, Hope, Hempstead County, Arkansas; died November 9, 1918, France.

SAMUEL MOORE, born August 20, 1891; died January 7, 1972, Randolph County, Arkansas; married DAISY ATCHLEY, December 20, 1909; born May 12, 1892; died January 31, 1991, Randolph County, Arkansas.

ENOCH GRAY MOORE, born November 28, 1894; died January 31, 1984, Hurst, Tarrant County, Texas; married EDITH IDELL CULPEPPER, March 23, 1919; born December 12, 1901; died December 20, 1980, Hurst, Tarrant County, Texas.

NORA ADEL MOORE, born August 11, 1896, Pike County, Arkansas; died July 6, 1988, Colorado County, Texas; married HENRY ELLIOT (SKEET) HILE; born November 5, 1886; died September 11, 1966, Colorado County, Texas.

PETE JACK MOORE, born August 24, 1899, Murfreesboro, Pike County, Arkansas; died December 26, 1972, Smackover, Union County, Arkansas; married ANNIE OPHELIA ALEXANDER, December 28, 1919, Belton, Hempstead County, Arkansas; born December 1, 1903, Murfreesboro, Pike County, Arkansas; died December 7, 1991, Smackover, Union County, Arkansas.

BETTY MOORE, born August 17, 1901, Pike County, Arkansas; died February 8, 1990, Yreka, Siskiyou County, California; married FRED LANE; born April 27, 1895, Missouri; died March 22, 1977, Yreka, Siskiyou County, California.

NANNIE MOORE, born August 28, 1904, Pike County, Arkansas; died April 26, 1943, El Dorado, Union County, Arkansas; married EARL BYRD BOWMAN; born February 27, 1900, Jefferson County, Arkansas; died January 10, 1981, Union County, Arkansas.

SUSAN CHARITY-4 PIERCE (NANCY ELEANOR-3 PRICE, PETER OLIVER-2, PRICE-1) was born September 16, 1872 in Farmerville, Union Parish, Louisiana, and died June 1959 in Chehalis, Lewis County, Washington. She married (1) JOHN ANDREW HESS, September 16, 1890, in Hempstead County, Arkansas, son of JOSEPH HESS and JULIA STREICHER. He was born April 25, 1865 in Maybee or Monroe, Monroe County, Michigan, and died March 6, 1894 in Pueblo, Pueblo County, Colorado. She married (2) AMBROSE FRANKLIN (FRANK) CASSIDY, June 21, 1896, in Lapwai, Nez Perce County, Idaho. He was born August 14, 1868 in Houlton, Aroostook County, Maine, and died December 9, 1954 in Chehalis, Lewis County, Washington.

Notes for SUSAN CHARITY PIERCE: She was adopted by Patrick & Catherine Donnelly after her Father was killed. Paterick Donnelly worked for the railroad. Also a girl by the name of Katie was adopted by the Donnellys and married Ambrose Franklin Cassidy's twin brother Jack. Jack's name on his marriage licence to Catherine Donnelly is M.C. Cassidy. Susan's adoption papers say her name was Susan Charity and her tombstone says Susan Charity but her oldest daughter Susie said her name was Susanna Josephine. Did the Donnellys rename her after she was adopted? Also her first marriage licence was signed Susie J. Donnelly. Her adoption was final on the 23rd day of January, 1880. The 1900 census shows her as S.C. Donnelly. Susan was first married to John Andrew Hess who died on March 6, 1894. A friend of Susan, Mrs. Hogan, wrote her on June 3rd, 1894 from Pueblo, Colorado and told her how much she missed her since she had left and that her husband missed John Hess very much since his death. Patrick Donnelly was 23 in the 1880 Census of Hempstead County, Arkansas and Catherine was 20 in the same census. I believe they bought land in Hempstead County, Arkansas in 1875 and also Pope County, Arkansas in 1885.

Notes for JOHN ANDREW HESS: John was a locomotive engineer for the Missouri Pacific Railway, from Pueblo, Colorado to Hoisington, Kansas and return. John is buried at Rose Lawn Cemetery in Pueblo, Colorado. He is in block 29 lot 399.

Marriage Notes for SUSAN PIERCE and JOHN HESS: John and Susie were married by Michael McGill, M.G.

Notes for AMBROSE FRANKLIN (FRANK) CASSIDY: Frank and his twin brother Jack left Maine in the year 1891. Enroute they stopped in Butte, Montana, for a short stay, but continued on to Lewiston, Idaho, where they met the Donnelly sisters, Susan and Catherine. They were married in a double ceremony in Lapwai, Idaho, at a Catholic Mission by a Catholic Priest named A. Soer on the 21th day of June, 1896.

SUSIE-5 HESS, born July 9, 1891, Pueblo, Pueblo County, Colorado; died March 7, 1974, Spokane, Spokane County, Washington; married FREDERICK RUSSELL HUME, November 17, 1909, Pine Creek, Alberta, Res. of Frank Cassidy; born September 4, 1885, Aylmer, Quebec, Canada; died November 29, 1975, Whitefish, Flathead County, Montana.

EUNICE HESS, born August 15, 1893, Pueblo, Pueblo County, Colorado; died September 10, 1981, Napavine, Lewis County, Washington; married (1) WILLIAM WALTER OAKES; b. August 10, 1871, Roseau, Roseau County, Minnesota; died January 3, 1933, Chehalis, Lewis County, Washington; married (2) FRED J. ZUCKER, January 1943; born October 7, 1907; died November 20, 1989, Centralia, Lewis County, Washington. Notes for EUNICE HESS: Eunice met Fred Zucker when she was in Fortine, Montana working as a cook for her brother in law Fred Hume. Fred Zucker was working for Fred Hume at the time. Eunice and Fred Zucker are buried in Section F, Block 5, Lots 305 & 306 at Claquato Cemetery, Chehalis, Washington. Chaplain Richard E. Barada was the officiate at the her funeral service. Notes for WILLIAM WALTER OAKES: Walter is buried in section 4, lot 8, Stickland Cemetery, Centralia, Washington.

Children of SUSAN PIERCE and AMBROSE CASSIDY:

AMBROSE-5 CASSIDY. Notes for AMBROSE CASSIDY: Ambrose was accidently shot by younger brother Dan when he picked up a gun and aimed it at Ambrose not knowing it was loaded. It was the gun that belonged to Pat Cassidy and he had not unloaded it. Pat's son Joe said it always bothered his father blaming himself for the terrible accident.

JOHN CASSIDY. Notes for JOHN CASSIDY: Died at a young age.

MATHEW PATRICK CASSIDY, born July 21, 1901, Nez Perce County, Idaho; died July 1983, Chehalis, Lewis County, Washington; married MILDRED (MILLIE) ELSIE McCLENON, Half Moon, Flathead County, Montana; born May 5, 1907; died September 1979, Chehalis, Lewis County, Washington.

HELEN J. CASSIDY, born April 5, 1906; died November 1985, Centralia, Lewis County, Washington; married CHESTER L. GESCHE; b. November 25, 1899; died April 1987, Centralia, Lewis County, Washington. Notes for HELEN J. CASSIDY: Helen and Chester are buried in section F, Block 5, Lot 307 and 308, Claquato cemetery, Chehalis,

Washington.

DANIEL ROSS CASSIDY, born November 11, 1908; died October 13, 1982, Santa Clara County, California; married ALICE MARIE WARD.

NELLIE C. CASSIDY, born August 19, 1911; died August 1987, Chehalis, Lewis County, Washington; married (1) ART SMITH; married (2) OSCAR H. AUST; born June 3, 1908; died December 27, 1996, Chehalis, Lewis County, Washington. Marriage Notes for NELLIE CASSIDY and ART SMITH: Nellie and Art were divorced when Sharon their daughter was 3 years old. Notes for OSCAR H. AUST: Oscar was in the US Navy during World War II.

FRANK M. CASSIDY, born August 8, 1913; died February 20, 1994, Centralia, Lewis County, Washington; married (1) JOANNE ----- ; married (2) EDWINA MILLER; married (3) DORIS A.; born October 29, 1927; died December 14, 1990, Centralia, Lewis County, Washington. Notes for FRANK M. CASSIDY: Frank and Doris are buried at Sunset Gardens Cemetery in the "Garden of Devotion" Lot 29, space 3 & 4.

KATHLEEN CASSIDY, born July 19, 1915; married LAURENCE (LARRY) HOWE; born February 7, 1912; died June 1979, Lane County, Oregon.

PETER OLIVER-4 PURTELL (NANCY ELEANOR-3 PRICE, PETER OLIVER-2, PRICE-1) was born September 15, 1883 in Farmerville, Union Parish, Louisiana, and died May 23, 1969 in Dallas, Dallas County, Texas. He married VERNA MAY GEISER, October 16, 1910, in Delight, Pike County, Arkansas, daughter of ELIAS GEISER and JOSEPHINE MARBERRY. She was born August 22, 1888 in Clark County, Arkansas, and died February 18, 1966 in Dallas County, Texas.

Gospel Preachers Who Blazed The Trail

M.R. Kelley was born in Pike County, Arkansas, Jan. 6, 1862. His father died when he was 15, leaving the wife with six daughters and two sons for Brother Kelley to support.

September, 1878, he obeyed the Gospel. Desiring to be full conversant with the teaching of the Bible, that he might teach it to others as well as know his every duty, he became a close student of the Book of Inspiration. Many nights he read the Bible by pine knot fires.

When he was twenty-eight years of age he was married to Miss Nettie Pierce. Moved to Texarkana, Texas and then in 1893 to Madison County, Texas, where in 1894 he began preaching. Since that time he has never allowed an opportunity to present the Truth to escape him.

By trade he is a carpenter and follows his trade for a livelihood, but preaches each Lord's day.

In 1902 he moved to Bryan, Texas where for two years he worked in a hardware store and preached each Sunday in reach of that place.

In 1907 he moved to Waco, Texas where he now lives. He spends some time working at his trade - carpentering. Each Sunday he preaches in that city or at some place in reach of there. His father and grandfathers were Gospel preachers.

He is a quiet, unassuming man, but has been a faithful preacher, and many have been baptized into Christ by him.

In 1839 Thomas Kidd left the home of his uncle and "in his roaming around" eventually reached Cairo, Illinois and worked on a steamboat upon the Mississippi river.

After Thomas Kidd and Sarah Jane Westerman married they remained in Crittenden County, Arkansas about one year and came to Pike County in 1850. He did some work at Center Point at a tannery and soon after moved to Texas, remained two or three years, then back to Arkansas for a short time. Thereafter he returned to Texas for two years, then removed to Arkansas and settled three miles northwest of Murfreesboro in 1856. Here he remained except for time spent in the Confederate Army during the Civil War.

Antoine

Long a settlement on the Southwest Trail (old Military road) leading into Texas, Antoine did not become an incorporated municipality until Oct. 24, 1897. However, it is known that French trappers and Indian traders explored the area as early as the 1700's. Antoine is a common masculine name to the French. The first known homesteaders in Pike County were French Catholics who lived a little south of town on what is now known as the East Farm.

The 1847 directory of Catholic churches report that Father James Donohue was buried underneath the altar of the Church of St. Francis Xavier at Antoine. It is most likely that a settlement had grown up around this early place of worship. It is known that Father Donohue made his first trip to Rocky Comfort (now Foreman, Arkansas) in 1845 and that he served it and other settlements where there were Catholics along the Southwest Trail in Arkansas. According to long-time resident Olen Hendrix, the Antoine Baptist Church occupies the site of the former Catholic Church. The town cemetery is directly adjacent to it.

Antoine is located in Pike County on Highway 26 about 20 miles northeast of the county seat, Murfreesboro, and about 24 miles southwest of Arkadelphia at the Antoine River. At the time of its centennial, it has about 195 residents and is no longer a hub of business activity due to economic patterns, disastrous fires and other elements of change.

According to an account in "Early History of Pike County, Arkansas," in 1890 the city had a post

office, bank, church, school, cotton gin, gristmill, bottling works, sawmill, blacksmith shop, two hotels, drug store, hardware, billard and pool hall, cafe, doctor, city hall, several merchandise stores and a two-story jail built of native stone. Six trains, two for passengers, passed through daily connecting to Gurdon on the east and to Womble (Norman) and other towns to the west.

Now there is a combination City Hall/Fire House, three churches, and a few small businesses as well as numerous residences. An effort is being made to build a city park. Also, still in business after more than 100 years is the Buford Hendrix Store. It was built in 1888 by the locally prominent W.P. Barton who sold it around the turn of the century to O.O. Meeks who ran it successfully until it was bought during the 1930's by Olen Hendrix. Buford bought it from his brother when he returned from World War II and has recently taken his son, Benson, in to the business.

The town name is pronounced a couple of ways by residents. Some say "ann-twine" and others say "ann-toyne." Perhaps correct French and the Arkansas dialect were not meant to mix.

Cemetery Records

The Pike County Extension Homemakers Council started their research, an inventory of Pike County, Arkansas cemeteries, in the 1960's with an update in 1983-1984. Their work comprises the records of 80 cemeteries, including some burial places, and records of the Lake Greeson, Narrows Dam Project area where four cemeteries, the Martin, Bush-Epperson and two unnamed, were relocated for the water reservoir.

In 1986 the Pike County Extension Homemakers Council published their compiled cemetery records in a 447 page book entitled "Pike County Arkansas Cemetery Records". In its introduction it says, "Because of the age and conditions of many markers and the handwritten lists that were turned in, we readily admit that there will be some unavoidable mistakes either in dates or spelling of these names. Also, many graves were unmarked. We hope this book will assist people in tracing family trees ... or have an interest in Pike County."

Census Records

The Federal census records are available as a microfilm publication of the National Archives and

generally found in major public libraries having well-established genealogy collections. They are also available for viewing at the National Archives in Washington, D.C. and the National Archives Regional Centers such as the Southwest Regional Center in Fort Worth, Texas. The census microfilm publications are available for purchase through the National Archives and Records Administration.

The first census for Pike County, Arkansas is the 1840 census with successive census records for 1850, 1860, 1870 and 1880. Almost the entire national census for 1890 was destroyed. The census for Pike County resumes with 1900, 1910 and 1920. In 2002 the 1930 census will be released. The Pike County Archives and History Society in Murfreesboro maintains a microfilm copy of the Pike County census records.

Certificates

Certificates of deaths for Arkansas begin in February 1914. The first death certificate for Pike County, Arkansas is that of Lawrance Nelson, February 2, 1914. These records are maintained by the Arkansas Department of Health and a copy of a death certificate may be acquired for \$4.00. Additional copies of the same death record are \$1.00 each when requested at the same time. The \$4.00 cost is non-refundable even when a death certificate can not be found and is applied to the search for the record. Address:

Arkansas is very fortunate to have indexes of the death certificate records in a series of volumes compiled and published by Desmond Walls Allen of Arkansas Research, Conway, Arkansas. One of their immediate values is not having to exercise a "hit or miss" when ordering a death certificate.

These volumes provide the name of the individual, the date of death, and the county where the death occurred. They are both in statewide and in regional volumes and the information is the same, only the arrangement and selection are different.

George R. Brock

George R. Brock enlisted as a Private in the original "Pike County Blues" the first company organized out of Pike County, Arkansas for the Confederate Army during the Civil War. When his company was mustered into service on August 17, 1861 it became Company G of the 4th Arkansas "McNair's" Regiment Infantry.

During George R. Brock's service the 4th Arkansas was assigned to McCulloch's Brigade in northwest Arkansas in late August 1861 and served in the Indian Territory, September and October 1861. Reassigned to McIntosh's Brigade, McCulloch's Division of Van Dorn's "Army of the West" in February 1862, they fought at Leetown battlefield at Pea Ridge on March 7-8, 1862. Reconsolidated at Van Buren, Arkansas, then marched overland to Des Arc, the regiment was transported by steamboat to Memphis in an attempt to unite the Army of the West with the Confederate Army of Mississippi to attack Grant at Pittsburgh Landing Tennessee, but arrived too late for the Battle of Shiloh. Reorganized at Corinth, Mississippi on May 8, 1862 they served in Price's Division, Army of the West, in the Corinth Campaign in May and June 1862.

George R. Brock was discharged from service on July 18, 1862 at Chattanooga, Tennessee.

(and) called in during this last illness ... but after an examination and the administration of some medicines which his stomach did not retain, he pronounced the case a hopeless one, and ... William M. Kizzia, county treasurer, Murfreesboro, Ark.

Were one to ask the leading characteristics of Mr. Kizzia as a man, the answer would come almost involuntarily that he is a safe, cautious person, unpretending, but well informed, universally es-

teemed and of unswerving integrity, a man who has been tried, but not found wanting, and one capable of discharging his official and private duties with competency. He was born in Pike County, Ark., in 1858, and is the eldest of nine children born to the union of Nathan and Isabella (Gould) Kizzia, ... natives of (Alabama and) Arkansas. Nathan Kizzia came to Arkansas with his parents when a small boy, and has followed agricultural pursuits all his life. He still resides (1890) in this county, and is an active member of the Methodist Episcopal Church. William M. Kizzia passed his youthful days on the farm, attending the common schools, and at the age of twenty-one years commenced farming for himself. In 1879 he entered 160 acres of land three miles east of Murfreesboro, and on this he has cleared about forty acres. He has a fine farm, good buildings and has plenty of timber. His marriage to Miss Amanda E. Burkett, a native also of Pike County, Ark., and the daughter of David Burkett, an old settler here, who died during the (Civil) war, took place in 1877, and four children are the result of this union: Nancy I., Dyer Martin, Em-mett Edgar, and Joseph Osgood (who died in infancy). Mr. Kizzia has always taken an active interest in politics, served two terms as justice of the peace, and in 1886 was elected treasurer of Pike County, being reelected in 1888. He is a member of the Masonic fraternity, Pike Lodge No. 91, and the family are members of the Methodist Episcopal Church.

Dear Dorothy:

I understand the Early History of Pike County Arkansas has been republished, and no effort has been made to correct the numerous errors contained in the "My People" story by Katye Woodall Whisenhunt shown on p. 220 in my copy. This

story is now posted on the Internet, and I've grown weary of explaining to cor-respondents that it is an inaccurate account of the early history of the Woodall family in Arkansas.

As you know, I am descended from Susan A. Woodall who married Jesse C. Fox and have done extensive research on these ancestors. I have complete documentation for the statements that follow. Specific problems with the "My People" tale are these:

1. Phillip Woodall (I), b. 1799 SC, his wife Susan "Sukey" (Heard) Woodall, b. 1797 GA, her illegitimate children, and their Woodall children, all lived in DeKalb Co., GA 1840, as proven by census records. They did not live in Cass Co. The Cass Co., GA Woodalls were cousins to Phillip (I). All children of Phillip Woodall (I) and Susan "Sukey" (Heard) Woodall were born in DeKalb Co., GA.

2. Phillip Woodall (I) d. c. 1840-45, DeKalb Co., GA.

3. After Phillip (I)'s death, Susan "Sukey" (Heard) Woodall and most of her children left GA and moved to Posey Co., IN. They had both Woodall and Heard relatives in Posey Co., IN and adjoining White Co., IL. They did not come to Arkansas in 1845! Daughter Nancy Woodall m. John Beal in 1841 and remained behind in GA; son Thomas Heard remained in GA; son Phillip Woodall (II) and illegitimate son William Heard were already in White Co., IL; illegitimate daughter Eliza Heard moved to IN with her mother and m. Richard C. Hanks in Jan 1848. Eliza d. in childbirth that same year giving birth to child Martha Hanks who was erroneously listed as a "Woodall" in 1850 census.

4. Susan "Sukey" (Heard) Woodall, all of her Woodall children except Nancy and Phillip (II), her son-in-law Richard C. Hanks, and granddaughter Martha Woodall/Hanks were listed in 1850 census records of Posey Co., IN. No member of this family was in Arkansas in 1850.

5. In 1851, John G. Woodall, Charles J. Woodall, Pascal Marion Woodall, and Samuel A. Woodall were arrested in Posey Co., IN and charged with grand theft. This incident prompted the family's removal from Indiana.

6. John G. Woodall returned to GA after his release from jail where he married Arminda Cupp. His first child, John P. Woodall, was born in GA in 1853, and his second child William Samuel Woodall, was born GA in 1855. By 1858, he was in AL, living near his uncle Jubal C. Heard, where his daughter M.S. Woodall was born. By 1860 he was living in Pike Co., AR near the rest of his siblings.

7. Susan "Sukey" (Heard) Woodall, the remainder of her Woodall children (son Philip Woodall II d. White Co., IL between 1850-55), and their spouses did not return to GA. They came to AR directly from IN after 1851 and before 1855. We know this is true because W.H. Cook, second son of Henry Cook/Knock and Julia Ann (Woodall) Cook was b. 1853 in IN., and James Haywood Woodall, first son of Charles J. Woodall, was b. 1855 in AR.

8. The names of the children of Phillip Woodall (I) and Susan "Sukey" (Heard) Woodall who came to Pike Co. AR were: John G. Woodall b. 1826, Charles J. Woodall b. 1827, Pascal Marion Woodall b. 1829, Elizabeth Woodall b. 1833, Susan A. Woodall b. 1835 and Samuel A. Woodall b. 1838. There was no son "Pachard".

9. Samuel Augustus Woodall was b. 1838. He would have been only seven years old in 1845. It's highly unlikely a seven year old would have had a "string of fine horses."

10. The Homestead Act was not passed until 1862 and was not widely applied in Arkansas. This act gave away 160 acres of land in the public domain to qualified persons. No doubt, the "My People" author has confused the Homestead Act with the Land Patent Act of 1854 whereby certain public lands could be purchased cheaply in under-developed areas. In fact, I have copies of my great grandfather Jesse C. Fox's land patent papers where he bought 40 acres near Kirby in December 1859 for seventy-five cents an acre.

11. Susan "Sukey" (Heard) Woodall, her Woodall children who came to AR, and their spouses, were all listed in the 1860 census of Pike County, AR.

I realize the "My People" piece was based upon an old man's recollections which he likely embellished, but his recollections simply do not conform to provable facts. Please issue some sort of disclaimer or qualifier to make clear re-searchers should not accept this story as the Gospel truth.

There's another bit of misinformation I'd like to clarify. My great grandfather's name was Jesse Carl Fox (Carl is the German equivalent of Charles). His name was not Jesse Carl Carl Fox. In other words, his middle intitial was "C." not "C.C." I have at least eight sources that show him as Jesse Carl Fox, Jesse C. Fox, or J.C. Fox. The only place his name is shown as Jesse C.C. Fox was in the 1880 Pike Co., AR census, and this latter listing is obviously the census taker's mistake. So please, folks, stop compounding this error by repeating it.

Dorothy, if you could get the word out on these

errors, you'll really save me a lot of headaches.

PCAHS would like to extend its appreciation to Eunice Fox Fontenot for providing an improved record of the Woodall family as given in "My People" published in the "Early History of Pike County, Arkansas" having specific and helpful corrections. Common to family research endeavor is information handed down that may not actually conform or varies to extent what a researcher may later discover through research effort. Published histories are often improved by later research and future research will again afford the opportunity of refining and improving. It is an aspect of family history and genealogy that is exciting especially when new discoveries are made or better information is found.

For reference, and especially for those who do not have access to the article referred to by Ms. Fontenot, is "My People" as represented in the "Early History of Pike County, Arkansas" (1st printing 1978, 2nd printing 1989) page 220-223. It was written in 1977 by Katy Woodall Whisenhunt, "as told to me by my Grandfather, William Samuel Woodall, years ago".

My People

Slowly, slowly turns the steady oak wheels, pinned to the cumbersome ox wagon. Puffs of blood red dust rise high over the fields, nostrils spread wide on the dumb faces of the huge necked beasts as they strain forward in double yokes - no shiny traces to help move the load.

Ho! Yo! halts the trample of tired hooves. Crack! splits the red dusty air about. A giant hairy arm slowly moves the mighty bull whip that has snipped a rattler's head from his obnoxious body. "Hey! Uncle Sam, give me the rattles," piped a five-year-old boy's voice from under the home spun canvas.

The long line of canvas roofed half circled sides of the ox wagon train held treasures, old china, cached gold, iron pots, spinning wheels, looms, feather bedding and pain. Pain, deep seated pain, pain that

strikes the heart of pioneer women when they have said no good-byes, but a farewell refrain, as they bounce and sway with the eternal motion of an ox wagon train. Not so with the men. Their hearts are lifted up with visions of westward lands, unknown dreams catch at the sun lines of their quick eyes and steady hands.

Leaving the gullied slave worked red hills and valleys of old Georgia behind, in 1845, these are my people, not strong as oxen in muscle and bone and sinew, but strong and active in man's spirit and God's, that leads them to try and to do the tasks, that built homes and the nation.

The sorrows of the great war for freedom of worship and to manufacture, to govern by the people, still lingered in the hearts from lectures - from the old ones, now moulding and have long since been gathered to their fathers.

This year, 1845, the spirit of unrest writhes and tortures our young nation from within. It groans and backbites, settles down again for a little season.

As the ox wagon wheels turn westward through nasty bog and filthy swamp, tired people with slow movement, over a log heap fire, making ready, low bent, a meal for a king. They are kings - and queens - but no crown do they wear. Their crowning day is yet to come. The hero's song is yet unsung.

High! High! Up! Up! the mountain top is gained. The mighty echo of Uncle Sam's voice swings back again and again. The thankful noise of it wraps the ox wagon train folk in a blanket of peace. As the evening star hurries from the East, the dumb beast that wear the yoke, somehow feels the gladness of the folk that feed him. He kneels as if to bless with them; no, no, he is just lowering himself to the ground for much needed rest.

Ever onward, no time to loiter, make haste. Today was yesterday's tomorrow.

I wish "I had a buckskin suit ... like Daniel Boone did wear," said five-year-old Sam, the nephew of Sam with the giant hairy arm that controlled the trigger finger that never missed the object, be it panther, deer, elk or bear.

Young Sam sank deep into a downy feather bed, in the upper berth, under the home-spun coverlet, dreaming dreams of a far off land, coming as if to meet them, as the wheels slowly turned over and over again. Wheels turning forward, on the greased axels, progress making, crude, but everlasting.

Downward, right on down, the dumb beast's winded nostrils slowly fell into natural lines, the hairy tough muscle under and outside of the smooth worn yoke of wood, relaxed for a time. The women sang hymns, stepping modestly behind, desiring to walk to rest their tired cramped spines from being too long inside low roofed wagons.

The children fought like bear cubs fight. Boxing and slapping inside their cage, laughing and looking with eager eyes. Wise eyes, because one's eyes make one wise. Wise to stay alive, in far behind days. Something at the foot of the decline was reflected in many eyes. In the strong, it meant a dare, something to defy, something yet untried - by them. In the weak, no, not fear, but an end to one thing, and a beginning on the other side. Yes, the flow of the father of waters was a turbulent rush this noon day. Wide, rough, hissing and pushing on its way. No, the mighty Mississippi could not stay my people. The ferry boat clutched them, hungrily, and beat the waves, lowered them, every one, their cargo safe - and now for more dangerous days.

Looking Westward from the muddy banks of the foe they had crossed, not with ease and satisfaction, but praying hearts and quaking knees, they bent low to pray for guidance on the way. Roll, roll, turn and turn again. The forest is dark, heavy and many eyes look and quick ears listen akin to fear, at the strange sounds, the clucking wheels, ever turning, bring my people nearer.

The valley is sighted - filled, packed down, measured out - through a gap in the mountain. A valley not large, but deeply and tightly held by the toes of a range of mountains, yet unnamed. The valley ... beauty left its garment here to endow it with gentleness, peace, no renowned fame, but fame all the same ... as I know it.

Long since gone are the red men. Silence reigns again in the valley. As for man's voice or footstep being heard no more in it, for times and times - but

God destined the time for my people to move into it. The end of a journey, now the gate to the frontier.

John Woodall and wife, Arminda Cupp Woodall, and five children, John II, William Samuel, and three other children of whom I do not know the names, John's brothers, Samuel, Charlie and Pachard Woodall with their families and three single sisters left Adaresville, Georgia in 1843.

They were moving to the western wilderness to homestead new land. They spent about two years in Alabama, headed westward again in early 1845. They stopped at Alpine, Arkansas, Clark County, in the Autumn of 1845, scouted land in Clark and Pike Counties and settled in a valley over the first range of mountains south of Kirby, east of highway 27 toward Murfreesboro. The country was a wilderness. No roads, no towns - Kirby, Murfreesboro, Glenwood and Amity were yet to be built. They cut timber and built a road into the valley which had a large creek flowing through it. They named the valley and creek Woodall. The name still remains the same. They and their families moved in and built log houses and barns on the 160 acres each that the brothers, John, Samuel, Charlie and Pachard homesteaded. (The original Woodall Valley is the one where the road sign reads "John Ashley Road".)

The nearest town was Star of the West on the Little Missouri River. This little town had a large water grist mill, flour mill, carding, spinning and weaving industry, shoe cobbler store and other commodity stores.

John's brother, Samuel loved fine horses and he brought a string of them with him from Georgia, although they made the journey by ox wagon.

A genealogy of my grandfather, William Samuel Woodall, son of John and Arminda Cupp Woodall is as follows:

William Samuel Woodall married Lou F. Heron of Alpine, Arkansas, Clark County, January 13, 1878. Eleven children were born: Zinkie (Nov. 12, 1878), William (June 22, 1880), Walter (Sept. 20, 1882), Minda (August 6, 1884), Edward (Feb. 10, 1887), Arthur (March 5, 1889), Nattie (June 23, 1891,

twins Cuthbert and Gadfrey (Oct. 23, 1893), Nora (March 2, 1896), and Dosha (Aug. 9, 1898). Samuel Woodall died November 17, 1927 and Lou died April 24, 1950. At Lou's death surviving were 83 grandchildren, 160 great grand-children, and 9 great-great grandchildren.

Samuel and family left Woodall Valley in 1887. He bought the Lightsy farm, four miles east of Kirby near the road from Kirby to Amity. The community was known as the Red Lands. Later it was known as Mt. Zion. In my lifetime it is known as Valley Grove.

Woodall Valley has returned to the wilderness. No Woodall lives there anymore but there are some landmarks of the family left. The old cemetery and certain kinds of blooming shrubs, such as japonica, crepe myrtle and honey suckle remain at the old homesites.

The four seasons are just as beautiful in the valley in 1977 as when my people settled it in 1845.

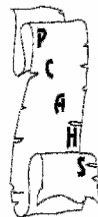
