

Melungeon Research

Have you had trouble tracing families back through the states of Tennessee, Kentucky, Virginia, North Carolina, or Georgia? Have you encountered the phrases: "Black Dutch," "Black Irish", or "raised as an orphan"? Have your been told that "great grandma was an Indian"? Are the oldest relatives reluctant to discuss their ancestors and/or where they came from? If you answered yes to any of these questions, there is a possibility you are looking for a Melungeon ancestor.

Have you been diagnosed with a strange ailment such as sarcoidosis, thallasemia, Bechet's syndrome, Joseph's disease, or Familial Mediterranean Fever? These are genetically transmitted conditions of Mediterranean origin that have been noted in families of Melungeon descent.

Most researchers agree that the Melungeons are a group of mixed-race people who have lived in Appalachia for at least 200 years, and some say much longer. In the past, the most common accepted name for Melungeons and all the so-called mixed blood groups has been "tri-racial isolates". These people were believed to be a mixture of Native American, cacausian, and African peoples. Research in recent years is proving that the issue may be much more complex than that. Genealogists have been joined in unraveling the intriguing mystery by linguists, historians and medical researchers.

For many years the name Melungeon was used as a derogatory name attached to the mystery group in Appalachia. One origin

mention is the French work Melange, meaning "mixture". Brent Kennedy in his research discovered the word Melun-can in the Turkish language. It is pronounced Melunjjun, meaning cursed soul, or one whose luck has run out. Manuel Mira found the name as Melunshawn in the Portuguese language. Eloy Gallegos found them in Spanish folklore as Melungos. Another source suggests a Romney connection. The name Melungeon is found in the Arabic, Portuguese. Spanish, Turkish, and Greek languages. In all instances, the name refers to persons disenfranchised from the normal population.

In another article published on the internet, the author says that one theory is that they are descended from the "Lost Colony of Roanoke" who married into the local Native American tribes. Others say that they were descendants of Welsh explorer Modoc who came to North America around 1100 AD, with ten ships of colonists. Still others say the Melungeons are the lost tribe of Israel, or simply lost Spanish explorers.

A sad fact is that these people of Melungeon heritage were often deemed "Free Persons of Color" or Mulatto on census and other records. Laws were made and set up to deprive the Melungeons of their basic rights, such as the right to vote, the right to own land, and the right for their children to have an education. Many families moved frequently, often changing their names in order to avoid such persecution. In a society where slavery was an accepted way of life, where genocide against the American Indian was government policy, hiding was sometimes the only way to survive.

According to an article with information from Nancy Sparks Morrison and Dr. Brent Kennedy, this discrimination was carried into the 1940's and 50's and perhaps even longer, because of the work of Walter A. Plecker, who was the state of Virginia's first director of Vital Statistics and an avowed racist. Plecker labeled the Melungeons, calling them "mongrels" and other worse terms, among them being FCP-Free Persons of Color, and their children labeled as Mulatto (M), and both of those terms coming to mean "Black".

Trying to find your Melungeon ties is not easy. Check census records for changes, ie from FPC to white, to Mulatto, to Indian and back again. This is not only for the direct lines, but your aunts, uncles, and cousins. Families would change to protect the children and also so that they could own land and vote. Some people have discovered the Melungeon connection by

having been diagnosed with one of the medical conditions that are characteristic of Melungeon There are some physiological heritage. characteristics called ethnic markers that seem to be passed on through the lines of some Melungeon deseendants. There is a bump on the back of the head of some descendants, about the size and shape of half a golf ball or smaller, or a ridge, located at the base of the head where it joins the neck. There is also a ridge on the back of the first four teeth-two front teeth and the ones on either side. The backside of the teeth also curve outward rather than going straight down as the descendants of Anglo-Saxon parentage do. Some Melungeon descendants have what is called an Asian eye fold. This is rather difficult to describe. Some people call these eyes, "sleepy eyes, dreamy eyes, or bedroom eyes". Some families have members with fairly dark skin who suffer with vitiligo, a loss of pigmentation, leaving the skin blotched with white patches. Some descendants have had six fingers or toes. (There is a family in Turkey whose surname translated into English is "Six fingered Ones.")

One source states that there is a resurgence of interest in the Melungeons every 20 years or so. In the past it was difficult to correlate research. Researchers were isolated and not aware of similar studies. With the advent of the internet, and the ability to share so much information in such short periods of time, will to doubt facilitate and accelerate current research.

Many of the surnames of early Pike County Arkansas settlers are listed on published lists of families with Melungeon connections. Nancy Sparks Morrison has furnished one that is relatively comprehensive. (No pun intended.) That list will be attached to the end of the article.

If you are interested in reading more, or think you may have a Melungeon connection there are several web sites on the internet with a wealth of information. If you do not have a computer, or are not "computer literate", you can go to your public library and use the computers furnished there. Someone can help you log on, then it is just a matter of moving a pointer and clicking a button to move around and select new screens of information. You just read from the computer screen or you can print out articles to read at home and/or keep for reference.

A couple of good pages to start from are http://melungeons.org. Once you get to the web sites, you can click on several choices and types

of information. Each link then also has choices to follow up.

For those of us who like the printed page, there are many articles and books listed on one of the web sites. Some of the articles listed are newspaper articles, some are magazine or journal entries, or graduate theses, other files are typewritten manuscripts or clippings in a folder of the Kentucky Historical Society or other such library collections. Check out the subject index at the library to find your own sources. If the articles you are interested in are not available in your local library, many times you can request an inter-library loan for articles from other depositories (although some material is not always loaned- for various reasons). One of the more recent books -now in the second printingthat is said to be very good is *The Melungeons*: The Resurrection of a Proud People. By N. Brent Kennedy, published by Mercer University Press, GA 1994. To order the book call Frontier Press at (800) 772-7559 or write them at P.O. Box 126, Dept. 212, Cooperstown, NY 13326. The book contains 156 pages, (cost is about \$20, paperback.) There is a new book on Melungeons that will be included in their next catalog within a few weeks. This new book is said to have many footnotes that will help in research.

Will of David R. Campbell

The State of Texas, Red River County.

I David R. Campbell, late of Hempstead County, Arkansas, and now residing in Red River County, Texas, being at this time in feeble health and knowing of the uncertainty of human life and feeling a conciousness of approaching dissolution, do make and publish this my last Will and Testament, hereby revoking all previous wills, testaments and written or verbal depositions of my effects.

Item 1st. I will that my body be interred at or near the Baptist Church in the Town of Clarksville, Red River County, Texas, in a decent and respectable manner, conformable to my pecuniary circumstances, and the views and wishes of my Relations and Friends.

Item 2d. I will and desire that after my funeral expenses are paid off and discharged that all my just debts to whomsoever owing shall then be paid off and discharged in due regard of my interests and reputation as a citizen and an honorable man.

Item 3rd. I will and bequeath to my beloved daughter, Elizabeth H. Dudley, widow, the house

and lot upon which I now reside, the same being Lot No. 8 (Eight) is in Block No. 93 (Ninety Three) fronting fifty (50) feet North on Jackson Street and fronting one hundred feed on the West on Travis Street and bounded on the West by Block No. Seventy One (71). Said lot lying in the N.W. corner of the block immediately East of Block No. Seventy One (71) and bounded on the East and South by the balance of the block.

Item 4th. I will and bequeath to beloved Daughter Mrs. Martha J. Stanley, the wife of F. M. Stanley, my buggy and horse now in my possession, and on my premises, the horse being a bright sorrel with three white feet.

Item 5th. I will that all my property in Arkansas and Texas, real, personal and mixed, of what kind or terms as may be considered best whether for cash; or on time, which is not herein before, or hereinafter disposed of otherwise, the proceeds of which first to be disposed for the payment of my debts, and then the overplus to be divided equally between my children. children of my deceased children taking shares equally through their father or mother, as the case may be, with my surviving children, that is to say, also the children of any deceased child to have and inherit as much as any one of the surviving children according to the provisions set forth in the items. The children included in the items are Mrs. E.H. Dudley, Mrs. M.J. Stanley, Jerome Campbell, Malinda A Campbell, Sophrona Gould, Mrs. Susan Erwin, Mrs. Cassandria Stringer and David Campbell, those deceased, their children inheriting as their deceased parents would have inherited if living. Item 6th. I will nominate, constitute and appoint my beloved and affectionate son-in-law F.M. Stanley the Executor of this my last Will and Testament authorizing him to carry out the stipulations and provisions of the same. I hereby require him to file with the Clerk of the County court of Red River an Inventory and appraisement of my Estate, after which, and his taking the oath required by the Statutes of the State in such cases, I desire no further action or control of my Estate to be had by the Probate Court of Red River County. And not knowing the requirements of the laws of Arkansas, I desire that my effects there shall be disposed of without the interference of the Courts, if the same be consistent with the Statutes, otherwise to be disposed of ; with as little expense as practicable.

In testimony whereof, I have hereunto signed my name in presence of Jordon Brewer and M.S. Sims, Witnessed called by me to

Witness the Execution of the same. This the 6th day of October A.D. 1866

County Court pertaining to Estates Nov. Term A.D. 1866 Monday, November 26th A.D. 1866

In Open Court at the present Term thereofafter the required application made and due notice given as appears to the satisfaction of the Court. The Will of David R. Campbell was produced in Court for probate, and the subscribing witnesses Marshall S. Simms and Jordon Brewer who being duly sworn say that they saw David R. Campbell the testator sigh, declare and publish the instrument to them now being shown being the date the 6th day of October A.D. 1866 as his last Will and Testament, freely, voluntarily, of his won accord, and without any compulsion or pursuasion or influence from any person whatever, that at the time of Executing said Will the said Testator was of sound disposing memory, that deponents signed said Will as Witnesses thereto in the presence of the said Testator, at his instance and request, and in the presence of each other.

Sworn to and Subscribed before me this the 26th day of November A.D. 1866

It appearing to the Court that the last Will and Testament of David R. Campbell, late of Red River County, Texas, deceased has as this Term been produced in the Open Court by Francis M. Stanley Executor thereof and no objections thereto being made, the same has been proven according to law by M.S. Sims and W. Jordon Brewer, the subscribing Witnesses thereto, and it appearing that to the satisfaction of the Court that said Will is in due and legal form, and that the said Francis M. Stanley, Executor as aforesaid has made and filed his application as required by Law for Letters Testamentary thereof to be granted to him at the present Term of the Court and that lawful notice thereof has been given, to which no objection has been made.

It is therefore ordered by the Court that the said Last Will and Testament of the said

David R. Campbell deceased, be admitted to Record, and that Letters Testamentary thereof be granted to the said Francis M. Stanley.

The State of Texas, County of Red River.

I, Henry Little, Clerk of the County Court in and for the County and State aforesaid do hereby certify that the five preceding and foregoing pages contain a true and correct copy of the Last Will and Testament of David R. Campbell, late of said County deceased, and all the proceedings had in the probating of said Will in said Court.

In Testimony Whereof I have hereunto signed my name and affixed the impress of the Seal of said Court of Office in Clarksville this the 20th day of May A.D. 1867.

Notes on the Campbell Family

David R. Campbell was born 1794 in South Carolina, the son of John Campbell, born between 1770-1800. David married Sarah (?), born 1798 in Virginia. The maiden name of Sarah's mother was possibly Christina White of Virginia.

David and Sarah Campbell had nine children: Jerome Augustus born before 1820, married Harriet N. Alexander; Melinda A. born between 1810-1820; Sarah Sophrona born 1823 in Smith Co. Tennessee, married William Bond Gould in November 1839 in Hempstead County, Arkansas; Cassandrie M. born between 1825-1830, married a Stringer; Susan M. born between 1825-1830, married an Erwin.; John born 1829 in Tennessee married Mary (?). David R. Jr. born 1838 in Arkansas married Mary (?); Martha J. born 1838 in Arkansas married Frances M. Standley; Elizabeth H. born 1840 in Arkansas married E. H. Dudley.

Family Connections/Notes Gould-Campbell-Hutchings-Chapel

Interest in researching the Hutchings family was stimulated by letters written by Horace Hutchings in 1862 to his wife, Cassandra Campbell Gould Hutchings, and his father-in-law, William Bond Gould. Horace died in December 1862, a Civil War Casualty. He never saw his daughter, Sarah Elizabeth.

Hutchings is a modern day spelling for Hutchen, Hutchins, Hudgins, and Hutchun. It is believed the Hutchings crossed the channel to England in A.D. 1066. The name evolved from Hugh to Huchun by 1276. All Hutchings can be traced to one or more Hugh Hutchins of old England.

Many of the early records were found in <u>Hugh Hutchins of Old England</u> by Jack Randolph Hutchins (Copyright 1984) p. 180.

As the writer was studying Census records in Gwinett Co., Georgia, she noticed a Hutchings family. One of the children was Horris. (Could this be the Pike Co. AR Horace?)

Sarah Elizabeth Hutchings Chapel (b 1862) was married to James William Chapel in 1879. (see Chapter VIII of Chapel book).

Sarah Elizabeth Hutchings Chapel's mother was Cassandra ? Gould (1842-1930).

Cassandra's parents were William Bond Gould and Sarah Sophrone Campbell (1823-190?). After Horace Hutchings died, Cassandra married Albert Covington and had several children.

William Bond Gould was born October 15, 1816 in New York. On November 28, 1839 he married Sarah Sophrone Campbell in Hempstead Co. Arkansas.

According to an article in History of Arkansas (county by county published about 1900{Goodspeed}), he was a native of Philadelphia and an early settler of Hempstead County, Arkansas. He later resided in Pike County. He was a member of the Masonic Fraternity Pike Lodge #91, in which he held all the principal offices. He served as Representative to the Senate from Pike County for several years. In July 1861 (age 45) He enlisted in the home company of the Confederate Army. They left Murfreesboro, Arkansas in July and marched to Van Buren where he was elected First Lt. Of the 4th. Regiment, under Captain Black and participated in the Battle of Pea Ridge. Their Captain died and Lt. Gould was elected Captain. Ill health soon forced him to resign this commission. In 1862 he returned home where he remained until his death on May 25, 1874.

No leads have been found concerning William Bond Gould's parents.

Sarah Sophrone Camp[bell Gould was born in 1823 in Virginia. Her parents were David Campbell (b. in S.C. in 1794) and Sarah-?—(b. in VA in 1798) There was a Christanna White living in the same household as the David Campbells in 1850. Perhaps she was Sarah's mother. They were living in Tennessee from 1823-1838. they first appeared on the Pike County census in 1850. Many Campbell families still live in the county. It is difficult to separate the families as there were many named John and David. Some lived in Hempstead County, AR prior to moving to Pike County.

Alene Hunter Elam of Murfreesboro knew some of the Hutchings family lived in Benton, Arkansas. A telephone directory showed mack T. Hutching's address, He was contacted and gave enough information to prove Horace Hutchings had brothers named John and Hickmon. Both were on the Gwinnetts 1840 and 1850 census and proved Hugh and Nancy were the parents. John, Hickmon, and Horace moved to Arkansas. Civil War records are available for Hickmon and Horace. Hickmon received seventy dollars a month pension from 1901-1906. The application was witnessed by Albert Covington.

Mack T. Hutchings had been told by his father that there were 22 children in this family. The writer was unable to prove this.

Hugh Hutchins was married in 1822to Nany Bisco, daughter of John Bisco as records in Lancaster County, Virginia show. A marriage record is also found in that county for Hugh's parents, Richard Hutchins and Milly Beene (1797-dtr. Of John Beene).

Richard (b 1775) was the son of Richard Hutchins (d 1786). The next generation was William Hortoz Hutchins (d 1760). He married Elizabeth William Hortoz Hutchins' father was John Hutchin (d 1723). He married twice. His first wife was unknown. Second marriage was to a widow, Frances Hortoz Cox, (d 1733). John Hutchings (1723) was the son of William W. Hutchings (d 1668). He lived near the Crotoman and Black Rivers in Lancaster County, VA. He married Elizabeth Green, Daughter of John and Mary Green, merchant of London. After John's death, Elizabeth married William Thatcher in 1669.

Perhaps William W. was the first Hutchings in America.

Letter from Horace Hutchings to his family during the Civil War. He died in CSA.

Arkansas Post, Arkansas County, November the 24th, 1862.

Dear Father,

Having the opportunity thought I would write you a few lines to let you know I am well at this time, hoping this will find you the same. I recd. Your kind letter dated the 17th and was proud to here from ;you. I have nothing would interest you. We had a good deal of excitement a few days ago, about the Feds. Our pickets said some of them was across White River and was

crossing. Still tho that has died away. They say there is feds at Napolian on the river. I can't say this is reliable for we here so much camp nuse. I never hang confidence in anything that we here. We have commenced building winter quarters at this place. Can't tell whether we will stay here all winter or not. Reckon we will if the Feds don't run us from here this winter and if we have a fight here as some suppose we will. Hope we will whip them and drive them back. We have some ;three or four thousand troop here at this time and they say we will have some three or four ridgements more here in a few days. We have no late war nuse to write to you. We here camp nuse everyday but you know what camp nuse is. I rec'd. a letter from Saney (Cassandra) 4 or 5 days ago. She said they was not all well. that some of them had the chills yet, also that Nath had got home and he was improving. Was glad to here it. Have not hered a work from Joe since one Mr. Patrick left the Springs a few days after you left there with Nath. He said he was very punny when he left him. Don't see why he don't write for I would like to here from him. You stated in your letter something about our gun receipts, said you gave them to John to have them find out wi\right. I have seen him once since he come in, but he never said anything to me about them and I have not seen him for some time. Don't know where he is. If I see him, will attend to it as soon as I can. You must write every chance for me like to here from you. I sent a letter home the other day. Have sent several home since we have been here. Will have to quit for this time. Will keep you all well informed where we are as I can do nothing more at this time. I remain your effectionate son, Horace Hutchings-to W.B. Gould.

Last letter Horace Hutchings wrote to his wife Cassandra Campbell Gould Hutchings.

Dear,

Camped at the Arkansas Post October the 14, 1862. I have another opportunity of writing to you. This leaves me well and hope when you get this it will find you and the baby Siney enjoying the same blessings. —Illegible—we started the Post the day before (?illegible) left White Sulpher Springs. Got 16 miles below Pine Bluff then was ordered to Clarington on White River. We went back to the Bluff and went on to Clarington. Got six moles of Clarington, then was ordered to this place. We landed here yesterday. Don't know how long we will stay here. Some say we will stay here all winter and

some say we won't. So I don't know ho long we will stay at this place, and don't know as I don't go to the Stayat (?spelling) home. (Illigible) to be the hope one time will soon come when I will be permitted to get home and stay there. They are fortifying here like they aim to make a stand here, but I call H a bad place for that business. We may stay here some time and we may not. Dawson's Ridgement and Portlocks Ridgement are here. Grandsted's Ridgement is gone to the North part of the state. We have orders and then they countermanded so often there is no sertainty where or when we will move to for I don't know no more than you do. So I tell you how to direct your letters if we stay here long. Ben Davis will starthis male again. I have not herd from you and Nath since we left the Springs. Would like to here from them. I look for has got well which I hoope he has. We here that Price and his army has got a flaging and Tandorne has ben captured. That is the report, tho I con't know whether it is so or not. Hope it is not the case. I don't write this for the truth, it is rumored in camp. So I never believe anything without I know it is so we never here nothing but camp nuse. We get----and bread to eat and some molasses and shugar. I have not learn to cook good yet. Some time I cook, if you could see the bread I bake, you would laugh at it. When I get home, I will show you what a good cook I am. I hate to cook worse than anything else.

Saney, you must write how much corn you made if you make enough to do you not-hogs are all can get your meate out of them or not and what you do for tobacco. And the first opportunity you get, send my pants, shirts, and shoes to me. Then I will be prepared for the winter in that respect. We have not drawed any more money yet and don't know when we will draw again, but will send you-----. If you & pa or Nath-----home or ;not and how Joe was getting along when you herd from; him last. Write what you do for paper. I tried to get paper to send to you, but could not get any. I try to get enough to write to you so as to keep you informed where we are as well as I can, and you must write every opportunity you get. I would like to here from you. Tell your pa and ma I send them my best respects and all the children. Hope this will find them all well, Press and family, too. Tell Linzy to be a good boy while I am gone and soon as I get home will take him to see (_____). Tell my Baby to be good and I will give her a present when I get home. Give my respects to Dave Campbell and family, also. Joe Stringer and family. Write soon as y ou can. I love to here from you. Give my respects to all the family and for ;you and the baby, the(?sp endrmest) love absent husband,

Letter from Family

Benton, Arkansas Sept. 2, 1975

Dear Mrs. Glass,

I am sorry but I can't help you much in tracing the Hutchings family.

My father was Frank Hutchings and his father was John Hutchings. He died when my father was a young man before he married but I don't know what year.

Dad was born Sept. 22, 1868, died April 10, 1952.

John, Horace and Hickman were brothers and I have heard dad say his dad (John) was the daddy of twenty-two children, but these three is all I know of.

Dad said his folks came from Georgia.

I don't know anything about the Thomas H. or Thomas J. you wrote about. Did you mean you found them on the Saline Co. in Arkansas census?

'I don't know what my great grandfather's name was. My dad, Frank, and Bettie or Elizabeth were first cousins.

My wife's father, Theodore Mansfield, was also a first cousin of Bettie Chapel. Aunt San (Cassandra Campbelle Gould) who married Horace H., was a sister of her grandma Mansfields. She was Sarah Sephrona Gould,

Hickman had one son named George Hutchings. He never married and lived with us most of the time when I was growing up. He died in 1945.

He had a sister Virgie and she had two daughters, Delmer and Annie who lived years ago in Hillsboro, Texas. I don't know what their last names were.

I have a brother Thomas Lee Hutchings. He lives at Dover. He has never had any children. I think he was named for my grandpa Lingo.

We have a daughter and three sons Stanley;, James, and Larry. As far as we know these three and their three sons Scott, Russell, and Shawn are the only descendants with the name Hutchings. We have three granddaughters, but their children wouldn't be Hutchings.

Are you a first cousin to Bonnie and Gertrude Fagen? What was your father's name?

Sorry I couldn't tell you more. If you are ever in Benton, we would like to meet you.

Isabelle (Belle) Gould married Nathan Kizzia, 1857. Their children were; Martin Kizzia, father of Cecil, Freeman, Dyer, etc. Joe Kizzia, father of Fred, Gracy, Floyd and Hallie Morrison. Oda Aurora married Virgil Hunter-children were Allene, Elam, Loraine Smith, and Parks. Ada Estella married Horace Fagan-children Homer, Irene, Gertrude, Bonnie, Roy. Jewel married Alva Womack-children Dewey, Mildred, Edna and J.W. After Horace Hutchings' death, Cassandra Gould Hutchings married Jas. Albert Covington, Jan. 16, 1867. Their children were Alice Deborah, who married John W. Elzychildren Paul, Ednah, and Marie. Mary Ann married Js. T. Henderson-Russell. Sarah Sophrone married Chas. Flemister-children Pearl, Myrtle, Clell, Olin, Ruth. Covington was killed by a train in early youth. Jerome Covington married Eva Ward-children Eva Hicks, Ira Covington, and Carl. Adopted daughter Mittie Gilmer married Jim Cooper children Orel, Clark, Stella, Bertie, and Wanda.

Jerome Augustus (Joe), born 1844, was a soldier in the Confederate States Services. As a member of Harts Battery, he was imprisoned at Arkansas Post, then taken by Federals to Camp Butler near Springfield, MO. He died March 20, 1863 at age 19

Malinda Watkins Gould was born in 1846, died 1847.

William Morse Gould was the father of John, Rolfe, Pauline, Laura, Kate, and Dr. Will Gould.

Sarah Sophrone Gould, born 1850, married Davis Mansfield on Jan. 16, 1867. Their children were Theodore, (father of Audrey, Cecil, Troy, Trudy, Judy and Felix), Will, Walter, and Goulie who married a Thomasson, their children were Madedell and Ozell.

Suzannah Tillman Gould, born 1852, married John Branch. Their children were Cade Branch, Ed Branch, father of Ruby and Harold, Claude Branch, father of Hugh, Nora, Estelle, Tommy and George, Nona Branch, and Mae Branch married Mack Ross. ;his court. He is now in jail, but bears his
confinement with good grace. He will be more

highly esteemed by the community than ever before.

The case against Adam Clark, junior editor of the Standard, for the same offence, was dismissed with a fine of five dollars and costs.

MILITIA OF ARKANSAS TERRITORY GENERAL ORDER ARKANSAS TERRITORY 1825

Head-quarters, Little Rock, June 10th, 1825

(Copied from the Arkansas Gazette of May 14, 1825 by David W. Bizzell, North Little Rock, Arkansas.)

The Commanding Officers of Regiments, Battalions, and Companies of the Militia in the counties of Pulaski, Arkansas, Crawford, Phillips, Chicot, Independence, and Lawrence, will report in person, or by letter, to the Adjutant General's Office, at Little Rock, on or before the first day of July next; those of Clark, Hempstead, and Miller counties, will make their reports to Brig. Gen. William Bradford, at Cantonment Towson, who will forward them to Head-Quarters.

The organization of the Territorial Militia will engage the full attention of the Commander in Chief, and will be proceeded on without delay.

The laws for the government of the Militia, will be rigidly enforced, and the zealous co-operation of those citizens who have been honored with Commissions, is called for and expected.

Lieut. Colonels Henry W. Conway and Ambrose H. Sevier have been appointed Aids-de=Camp to the Governor. They will be obeyed and respected accordingly.

William Orrick Family

Barbara Denny furnished the following information on this Orrick family.

William Orrick was born about 1784 in North Carolina. He married Celia Ola Strickland around 1806. Celia was born about 1788 also in North Carolina. Both died in Pike County, Arkansas, Celia around 1862 and William following somewhere near 1865.

William and Celia Orrick had twelve children. Their first son, James Orrick, was born in 1808. He grew up and married a woman named Mary --?--. The second child, Asa Lenox Orrick, born in Alabama in 1810, married Hannah Abernathy and died in Franklin County.

Belinda Orrick was the third child, born in 1812. She married Howard Dillard June 4, 1840 in Harrison County Texas. Nothing is known about the fourth child, Susan except that she was born January *, 1814. The next daughter, Nancy, was born February 3, 1816 in South Carolina. She died November 10, 1875 in Pike County, Arkansas. She was married to Madison Ewing Alford on October 24, 1833 in Morgan County, Alabama.

Sixth of the twelve was William Jackson Orrick, born March 27, 1818 in South Carolina. He married Rebecca Elmira Dyer about 1840-1841. He died July 14, 1893. The brother next in line was Andrew "Abe" Orrick, born in 1819 in Alabama, died in February of 1860 in Pike County, Arkansas. There was a boy child born in 1821, and a daughter named Celia born in 1823, (no further information given).

Child number ten was Thomas Lorenzo, born June 24, 1825 in Alabama. He married Polly Ann Yoboro in Arkansas in 1847. He died December 15, 1914 in Fort Worth, Texas. We only have the names and birth dates of the last two children. Eleven was Furnck, born 1827 and twelve was Ephriam, born 1831.

WILL JOHNSON KILLED BY LIGHTNING LATE WEDNESDAY

Had Taken Refuge Under Small Trees During the Electrical Storm.

Will Johnson, aged 58, well known carpenter and contractor who had lived here for many years was killed by lightning late Wednesday afternoon during the electrical storm that preceded and accompanied the heavy rain that fell here then.

He had been farming on the Ross Place just west of Dierks and which lays along Rock Creek just south of U.S. 70 highway about half a mile west of town. He was picking peas there yesterday but did not return home last night. He lives in the north part of Dierks. Mrs. Johnson went out to look for him this morning, but on learning that he was not at the Ross home, she and Mrs. Ross and Tubby Lockaby went down into the field and found the body by his wagon under some small trees. He had covered the peas he had picked and had put his raincoat on and a sack over his shoulders. His body was burned by the lightning and his left shoe bursted and burned. He had fallen over backwards when the bolt struck him according to those who viewed the body. Henry Griffin, J. P. and Dr. C. A. Campbell were called to the scene and examined the body and stated that an inquest was not necessary;, it being clear that death was caused by lightning. The body was carried to his home here at about 11 a. m. this (Thursday) morning.

Funeral arrangements have not been announced at press time. The deceased is survived by his widow and two daughters Mrs. Horace Rankin and Mrs. Maxine Evans, both of Dierks and two granddaughters.

My brick wall is the John and Nancy Davis family from Smith Co., TN who settled in Pike Co., AR after the 1850 census.

John Davis b 15 Apr 1802, NC (County unknown). I know nothing of his parents or siblings. He married Nancy (Reece?) abt 1825 (probably TN) and had the following children: Tabitha b 1826 (married a Burkett??), John Dee b 1826 (married Elizabeth Rebecca Smith TN), James W. b 1831 (married Martha Henderson AR), Mary Ann (married James T. Parson AR), Ellen b. 1835, Matilda Jane b 19 Aug 1837, (married Abner Newton Henderson Jr. AR), Josiah b 1839 (married Margaret Hargis), Richard b 1841, Elizabeth b2 Aug 1843 (married James M. Gill), Marenda b 2 Aug 1845 (married Andrew Jackson Henderson), and Paralee b 1847. He lived in Smith Co., TN in 1850, but moved to Arkansas by 1860 and died there in 1881. Believe Josiah was killed in the Civil War, don't believe he or Tabitha moved to Arkansas. Several in this family are buried in Brocktown Cemetery and Saline Cemetery.

The end of May while attending the Four Corner's Ancestor Fair I attended a lecture pertaining to Church Records given by Russell Baker. During his presentation he showed a slide with information pertaining to my great, great, great grandfather Robert McMahan and an un;cle, Thomas McMahan, son of Robert. There was not time for me to copy the information and after the lecture, I asked him where he had obtained the information. He said it was from the Antioch Church Records, Christian Chiurch, Delight, AR.

I recently spent the day at the AR Historical Commission and read the Antioch

church records on film from back to front and did not find the information I wanted. I then read the book by David Kelley of the same records, this time reading front to back, and still did not find the information.

When I questioned Mr. Baker the third time as to source of his information, He said I should contact you. I am particularly interested in any information pertaining to Thomas McMahn as he is the only child of Robert and Nancy Kester McMahan that I have been unable to complete a group sheet on.

In April 1833 Thomas, Francess (age 7), Ann, Nancy Jane and Permelia McMahan are listed as being members of the Christian Church, Antioch Congregation. Thomas McMahan had joined this church in 1848 byt had dismissed his membership (reason not given) but probably because he had either moved or died on Sept. 1850. I have no reason to believe he died Sept. 1850. I do not know whem he married. I only have information on son Francess who was ordained a minister in 1854 and moved to Hempstead Co., AR. Francess McMahan b IL and married Ann Griffin. Their children:

Albert Montgomery McMahan b 27 apr. 1849 married Nancy Sarah Taylor, Thomas E. McMahan born 2 Feb. 1851 married Mary Hoke William Jess, John Fields McMahan never married, Arkansas Permelia "Sis" McMahan b 30 Dec. 1854 married John W. Patterson, Sarah Christine McMahan b 5 Dec. 1856 married William Henry Kelley, Mary A. McMahan, and William Jesse "Bud" McMahan never married.

Francess McMahan died in AR. Last mention found of him was a marriage record in 1863 where he is the minister officiating the soleminization. Hampstead Co. AR. His son, Albert H., moved to Madison Co., TX when he was about 21 years old. Ann Griffin McMahan did go and stay with son, Albert, and son-in-law William H. Kelley until she moved to Jester, Greer Co.,OK with her sons John F. and William Jesse. She died and was buried at the cemetery in Jester, OK about 1907.

I do not know if Mr. Baker has referred me to a professional genealogist, a newsletter editor, or what....I would appreciate hearing from you.

Thanks so much for you letter and newsletter of Pike County. I really do appreciate your time for this. I'm enclosing a query for your newsletter, anytime you have the space. I'm also sending my membership dues to Linda Wilson, would like to be a member of your society. You really have an interesting newsletter and I enjoyed reading this one, even though I didn't find any of my family init. But who knows, I might sometime. I also appreciate the addresses of the ones researching the Whisenhunts. I'm going to write them, but I've been trying to get these things together to send you first.

My Jones family from Pike County were Wiley B. and Nancy (Lucas) Jones. They came to Pike County before 1850 from Bedford County Tenn. I have them on the 1850 census of Pike County but can't find them on any 1860 census. So I don't know what happened to him. He is my gt., gt., grandfather. His daughter, Lina, who married William R. Carlile is my gt. Grandmother and she is buried at Lee Cemetery, just outside of Roxton, Texas. I know she was here with her mother, Nancy (Lucas) Jones by 1863 as that is when she married the Carlile. We have some double cousins in this Jones and Carlile family. Lina's mother married William R. Carlile's father here in Lamar County in 1871, then we had some brothers and sisters that married. Really has been a hard family to trace.

Mary Jane (Jones) King married Adam Whisenhunt but I don't know if they married in Texas or Arkansas, but we found them on the 1870 and 1880 census together in Pike county. I have been unable to find Mary Jane with the Walker on the 1900 census anywhere. Do you have a printed census for 1900 or Pike county that might show them? Since she died in 1906, I thought maybe they were here in 1900, but I couldn't find them on it.

I'm enclosing ancestor charts and group sheets for you to place in your library. Do appreciate you asking about those I've highlighted my Jones line....but still haven't found anything about Wiley B. Jones.

Short Biographical Sketches from Mildred Class's notes

Sarah Elizabeth Hutchings

Sarah Elizabeth Hutchings was born in Murfreesboro, Pike County Arkansas in 1862. She married James William Chapel in 1878. He was born in Henry County, Georgia in 1850 and moved to Arkansas in a covered wagon in 1865. He died in Murfreesboro in 1928 Sarah Elizabeth died in Murfreesboro in 1936. Both are buried in the cemetery at Murfreesboro. Their children are; Oda Aroria, Ada Estella Amanda Cassandra, and Horace Jewel.

John Campbell

The oldest Campbell in this line that has been traced is John Campbell. This family was found on the 1800 Census for Fairfield, SC and the 1810 census for Chesterfield County in SC. John was born between 1770 and 1780. By the 1820 census, they had moved to Smith County, Tennessee. Other names in this family are:David R., Doogle, John Joseph, and William. Ages in the census records in Smith County, TN prove this is the same Davie R. that appeared in Hempstead County, Arkansas in 1838.

David R. Campbell

David R. Campbell was born in 1794 in South Carolina. He was found on the 1820 and 1830 census rolls in Smith County, TN. His wife was Sarah--?—born in 1798 in Virginia. This family moved to Hempstead County, Arkansas in 1838 or before. A copy of his will shows that he was living with his daughter at the time of his death in 1866 in Red River County, Texas.

Sarah Sophrona Campbell

Sarah Sophrona Campbell (3rd child of David R. Campbell) was born in Tennessee or Kentucky in 1823-probably in Smith County, TN. She married William Bond Gould in Hempstead County, Arkansas in 1839. This part of Hempstead County later became Pike County. W. B. Gould was a cabinet maker born in New Yorkin 1816. He served in the Civil War as a Captain, and also was a member of the state legislature. He died in Murfreesboro, Arkansas in 1874.

Her Great-grandson, Horace Jewel Chapel remembers seeing her smoking a small pipe after each meal, and remembers that they grew their own tobacco.

Cassandra Campbell Gould

Cassandra Campbell Gould, 2nd child of Sarah Sophrona Campbell Gould, was born in Hempstead County, Arkansas in 1842. This part later became Pike County. She married Horace Hutching in 1860. He was born in Virginia in 1833. He and several of his brothers moved from Gwinett County, Georgia to Arkansas between 1850 and 1860. He was a soldier in the Civil War, a member of Hart's Battalion. He died at Arkansas Post December 22, 1862. The only child of this union was our ancestor, Sarah Elizabeth, born in 1862.

Cassandra married James Covington in 1867. To this second union was born: Jerome, William Fletcher, Sophia, Mary, and Alice. Cassandra died in Pike County Arkansas in 1930.

The following article was found in the Friday, July 11, 1969 *Pike County Courier* and submitted by Dorothy Partian in reference to the Westerman material in the last issue of *The Gems*.

Stream of Life

As you read this I will be in Dallas giving to Clara White Carrigan the memories sent to her by several kind residents of Murfreesboro. In response to a plea in last week's column for information pertaining to Ezekiel Thomas White and his wife, Bell Westerman, my telephone rang and I started a journey backward into time and memory. Three Days later I stood in College Hill Cemetery. I gazed about at the tall, green trees walling in the silent graves, some with stones bearing names and dates and many other with only a small native rock to mark a final resting place. Some are perhaps unmarked even in this simple way.

In the stillness of the June morning we watched a lone hawk flying silent sentry duty above this haven of rest. Our search brought our gaze to rest on the small oval, gray stone marking the grave of Bell Westerman White. The unmarked stone rested in the shadow of the taller, native, brown stone, also unmarked, of Stacy Westerman, Bell's mother; in death as in life a mother stood as protector over her child.

From the alert minds of Mrs. Walls and Mrs. Strawn came many childhood memories of the Whites and Westermans.

They well remember Bell Westerman as a pretty girl of average size with blue eyes. Her hair was almost black and naturally curley. Bell wore her hair up, as was the style of the day;;, and when she took it down it tumbled about her shoulders. A daughter, Clara, was born to Zeke and Bell in 1902 and Bell died of swamp fever in 1905 and was buried in College Hill Cemetery.

After Zeke and Bell married they lived with her parents, Newt and Stacy Westerman. The Westerman home was a large, one story house with a wide hall running thru it. It was located across the Muddy Fork River. Stella and Beulah Buckley lived close to the Westermans and attended school and church with the Westerman children. The Westerman children were Amanda Tucker, Della Reese, Ann Henderson, Mary and Martha, both married Stewarts, Bell White, Jack and will.

At that time the school and church both met in the same one room building called "Over in the Fork of the River." At a meeting in the building a vote was taken and Heneretta Brown White's name of College Hill was chosen as the name of the building and the cemetery that was to become her final resting place.

Liddie Coker was the mother of Stacy Westerman, grandmother of Bell and greatgrandmother of Clara White Carrigan.

Stella and Beulah Buckley hid by the chimney in Liddie Coker's house and listened as she talked to herself when Liddie discovered them, they ran into a nearby orchard and hid themselves.

Liddie, dressed in her ankle-length, black riding habit, would lead her mare Fannie to a stump in her yard. She would climb onto the stump and from there mount Fannie and ride side saddle from "Over in the Fork of the River" into Murfreesboro. Swinging from there arm as she rode, and everywhere she went, was a large, long, black and white checkered handbag which Mrs. Stella Walls vividly recalls. Mrs. Walls and Mrs. Strawn are third cousins to Clara White

Carrigan. Their grandmother Oliver was a sister to Stacy Westerman.

After Bell's death, Zeke (Ezekiel) White returned to Mt. Ida then called Black Springs, with his small daughter Clara. He told her, "I've got to make a living. You can be a good girl or a bad girl." Until he died Zeke was very proud of Clara and told his relatives what a good girl she was.

Zeke married a second time to a woman named Alice and two daughters were born of this union.

Zeke's third wife was named Martha and to them were born four daughters and one son

Zeke's father's name is unknown, but his mother was Heniretta Brown and she bore six children; Hany, Zeke, Harvey, Marvey;, and two daughters, Lizzie and Billy.

After Mr. White's death his widow married George Holland, a bachelor, and bore him four children: Tom, Mae, Paralee, and Jewell. Tom Holland still resided in Murfreesboro and is about 70 years old. Mr. Holland is a half-uncle to Clara White Carrigan.

Other of Clara's relatives in Murfreesboro that are known to me are Mrs. Ben Lingo and Mrs. Horace White. Their mothers were sisters of Bell Westerman. Mrs. Kenneth Lockaby and Pearl Brock are also relatives. Evelyn Jackson, whose hobby is cataloging cemeteries, has furnished much information for this article. Both she and Jimmy Keyes called and gave me the information about Mrs. Ben Lingo. Edna McHughes read last week's article and called Mrs. Pearl Stringer who then called me.

Zeke White in later years visited in the home of Henry and Pearl Stringer. At that time Zeke was a barber. Mrs. Stringer has a picture of Zeke.

Mrs. Stella Walls and Mrs. Beulah Strawn took me to College Hill Cemetery and told me of their tenderly nurtured memories of the Whites and Westermans.

THANK YOU Evelyn Jackson;, Mrs. Ben Lingo, Edna McHughes, Pearl Stringer, Jimmy Keyes, Vivian White, Mrs. Tom Holland, Mrs. Stella Walls, Mrs. Beulah Strawn for letting me take your memories to Clara. By your compassion you have made Clara's cherished dream a reality. You have sent Clara a "smile" to replace her tears.

Book Review

Southwest Arkansas Regional Archives (known as SARA) has many resource materials, some are to be used on the premises, others are available for purchase. One of the books that can be purchased at SARA is <u>Sam Williams: Printer's Devil.</u> Edited by Mary Medearis, published in 1979 by Etter Printing Company of Hope, Arkansas 71801.

The introduction explains that the term "Printer's Devil" is a person who is learning the trade of a printer. Sam Williams was a printer's devil and as he was learning his trade, he wrote "Memorabilia", without a doubt his life's masterpiece. He wrote briefly about himself as follows:

"....Saturday;, the 8th day of March in the good year of our Lord 1851 found the writer

installed as a Printer's Devil in the office of the Washington Telegraph, of which William H. Etter was publisher, editor and owner."

Page 90 has reprinted copies of two advertisements that were printed in the Washington Telegraph. One is advertising rates for room and board at Washington House (example: \$15.00 board and lodging per month). The other is advertising a ball.

The Washingtonians of the good old days were a God-fearing, church-going people as they are to-day, and at the ringing of the bells on the Sabbath, morning and evening, nearly the entire population was wont to repair to the temples of worship and listen to the preaching of the Word

Kelley

One of the very early pioneers of southwest Arkansas was Elijah Kelley. He was born in Jackson county, Tenn., in 1803, and came to Arkansas with his father in November, 1815. They located on Wolf Creek, in what is now Pike county, but all that country was embraced within the geographical limits of Hempstead county when the Territory was organized. stopping there was purely accidental. started out from Tennessee to go to Texas, but they became water-bound at Wolf Creek. It was a beautiful valley—a modern Arcadia—and old man Kelley, believing that he might go further and fare worse, gave up all idea of pushing on to Texas and located there. A man by the name of Halifield, who was then 70 years old, and had been living there several years, sold the Kelleys the first corn they consumed in their new home. They paid 12 ½ cents a pound for bacon the first year of their residence. There were then (1815)

just six settlers on Wolf Creek and the Antoine, and the same number in what is now Clark county. At that time Christopher Anthony, William Grayson and Stephen Vaughan were the only settlers in the country west and south of the Little Missouri. There is to-day a stream near Prairie d'Ann known as Vaughan's Creek, which was named after Stephen Vaughan. He was the first white settler in that whole region, and must have located there somewhere about 1810.

Elijah Keley had fifteen children born to him, all of whom grew to maturity and married. He has living seven or eight grandchildren, and over two hundred descendants. He was for more than fifty years a minister of the Cammpbellite or Christian church. He occupied many positions of trust. He was a delegate to the Constitutional Convention of 1836, and outlived every member of that body except Gen. G. D. Royston. He also served in the State Legislature. and was for several years County Judge. He was a man of great personal dignity, and was endowed with the strictest integrity and the purest and simplest Christianity. He was plain and unassuming in his manners and simple in his mode of living. While he was a man of no great acquirements in learning, Elijah Kelley possessed an extraordinary fund of common sense, and was always an ardent Democrat. His brother, William Kelley, who was his senior in years, settled and lived within a few hundred yards of Elijah. He too, was a Campbellite preacher for more than a half-century. He was County Judge of Pike for several years. He was gifted with phenomenal memory, and possessed the extraordinary acquirement of being able to recite by heart the entire New Testament. William Kelley also raised a numerous family, and his descendants are scattered throughout Southwest Arkansas. William J. Kelley, who was a lawyer, and for a long time Clerk of Pike county, was his youngest son. All of these younger Kelleys were proverbial for their probity and Christianity, All of them were strict members of the church and many of the male members of the family were preachers. Rev. Samuel Kelley, at present, I believe, living in Howard county, who served in the Legislature in 1852, and in the Constitutional Convention which passed the ordinance of secession in 1861, was the eldest son of William Kelley. He, too, is a Campbellite minister, and has preached the Gospel for more than forty years. He is a man of strong practical sense and sterling integrity, and commands much respect. Until within a few years he lived in Pike county.
